Presbytery of San Jose Minutes of Stated Meeting Saturday, February 4, 2023 Via Zoom

The Stated Meeting of the Presbytery of San Jose was called to order at 9:05 am by the Moderator, Elder Elsa Amboy. Moderator Amboy introduced herself, then called on the Rev. Jack Cabaness, Pastor of Covenant, Palo Alto, for the opening prayer.

The Rev. Cabaness gave a meditation based on Matthew 6:25-34, and with references to the movie "Groundhog Day." He noted that there are a variety of religious/theological responses to the movie and the idea of events that happen over and over again. He pointed to Jesus' words: there are moments of Kairos time, where you can see everything God intends.

Outgoing Moderator the Rev. Nan Swanson installed Elder Amboy as Moderator for 2023, using a liturgy that included installation questions and prayer.

The Presbytery turned to the day's agenda, with Stated Clerk Erica Rader noting minor docket changes, the presence of a quorum (8 ministers, 8 Ruling Elders and 6 churches represented) and that there were no corresponding members present. First time attendees were introduced and welcomed.

Report from Executive Presbyter the Rev. Joey Lee

Good morning Presbytery. I have 5 joys and 5 concerns.

My Five Concerns

- 1. The state of our nation. From unrelenting gun violence, persistent racism, an ever increasing wealth gap, and a political divide that only seems to get wider and wider, I seem to oscillate between heartbreak, anguish, and numbness.
- 2. The state of the world. Can I just leave it at that? Sometimes I feel like that meme of a dog sitting with a cup of coffee. The room around him is on fire and he says, "This is fine."
- 3. Our pastors. It has been a tough three years. Unprecedented times and conditions. And while everyone seemed to successfully pivot during COVID, we are all still trying to figure out the new normal and what's next. I know pastors are tired, anxious, busy, stretched, challenged and...fill in the blank.
- 4. Our congregations. We are not different than the rest of the country in terms of church life. Our trend lines are in slow decline even as our average age increases. Our buildings are also aging and that puts additional stress on our budgets. In an increasingly secular culture, going to church is feeling very counter cultural. The busyness of our lives, the pull on our time and resources. All this challenges us and our faithfulness.
- 5. Our presbytery. Challenges to pastors and congregations are challenges to the presbytery. Stress on your budgets stresses our budgets as well. Decline in your membership is a decline in our membership. The health of a presbytery is directly tied to the health of its congregations and pastors.

My Five Joys

- 1. Our nation. There is nowhere else I would want to live. Our natural beauty, our freedom, our democracy, though fragile, remains the envy of others. Many of you know that I come from a refugee family. My parents were so grateful, and really loved this country. People don't seem to realize how much most immigrants, if given a chance, will love this country.
- 2. Our pastors. Your faithfulness and service, your creativity and vitality bring me joy. You tend to your flock. You visit the sick and lonely. You pray with the bereaved. You laugh with the children. You get dirty on mission trips. You endure attitude and criticism. You preach and teach. You listen and care. You encourage others. You encourage me.

- 3. Our congregations. I've wondered in the past how many meals are served by our congregations in a year? How many food boxes or articles of clothing are shared? How many children attend a day care or preschool on our campuses. You support missions in our cities, across the county and around the world. You work with other community groups, you work with other faith groups, you house the homeless, you visit those in prison, you help get guns off the streets and write or call our elected leaders hoping to speak truth to power. You try to be...you are salt and light to the world.
- 4. This presbytery brings me joy. We have a wonderful staff team. Erica, Collette, Diane, and Edd. Jenni does a great job with the newsletter and communications. We have two administrative commissions working to enhance urban ministry in San Jose and Watsonville. Ryan reminds us about issues of hunger and wholeness, and if you need to spend some time on the water, he captains our catamaran. I may be mistaken but we may be the only presbytery that owns a boat for ministry. And someday soon we will be able to toast at the public house and that ministry. Looking forward to it Robby. Friends we are a small presbytery. But we punch above our weight class. Erica and I are reminded when we talk to colleagues how blessed we are to have faithful elders and ministers who do the work of the presbytery, by way of our coordinating council, our committees, commissions and working groups.
- 5. Love brings me joy. The love of my family. The love of God that I know in Jesus Christ. When I pause, when I listen in silence, when I worship in our churches, when I think about the saints upon whose shoulders I stand, I know the love of God. It's more than joy. It is peace and it is grace.

Madame moderator, this concludes my report.

Land Acknowledgement

Moderator Elsa Amboy gave a land acknowledgement. She also noted that there would be an extension of the Zoom time after this meeting to allow for brief conversation among members of the Presbytery.

Committee on Ministry

The Rev. Mark Peake introduced new minister Member At Large, the Rev. David Koeker. His biography is a part of the COM report, Appendix C. The Rev. Koeker was not present at the introduction, but joined the Presbytery meeting and was acknowledged later.

The Rev. Peake pointed to the COM report. Stated Clerk Erica Rader thanked the Committee for walking beside churches in transition.

Mission and Outreach Work Group

The Rev. Vincent Arishvara reminded Presbyters of money available for mission projects: \$2,500 per congregation, and \$6,000 for two or more congregations working

together. Examples are Evergreen, San Jose with a food bank and clothing project, or Cornerstone, San Jose, working on a safe parking project for the unhoused.

The Mission and Outreach group wants to build a Mission network; congregations will receive a survey followed up by a phone call asking about missions.

The Peru trip is still uncertain because of political unrest in that country.

Committee on Nominations

Committee chair the Rev. Irene Pak Lee presented a motion to elect and Presbytery <u>voted approval</u> of the following:

Erik Swanson (TE Westhope) Personnel Committee (Class of 2025) Denise Martin (RE Gilroy) Chair, Personnel Committee (previously elected member)

Sub-Committee on Polity and Government

Chair the Rev. Bryan Franzen reminded Clerks of Session that Statistical Reports are due on February 10.

The Rev. Franzen then led the Presbytery through the process of voting on Amendments to the Constitution of the PC (USA). See Report, Appendix B. The Rev. Franzen added that the May meeting of Presbytery will provide educational resources together with a recommendation for the Amendments concerning the Misconduct and Discipline process in the Polity and Government report.

First Poll: Electronic Meetings 22-C, 22-M, 22-N. Committee recommendation was a "yes" vote. The Presbytery <u>voted approval.</u> ("Yes" 70, "No" 2)

Second Poll: Ethical Conduct 22-G, 22-K, 22-L, 22-O, 22-P. Committee recommendation was a "yes" vote. There were a number of questions on this grouping and considerable discussion. A motion to sever 22-P (dealing with antiracism policy) from the other four dealing with boundary training was presented and approved by vote.

Amendments 22-G, 22-K, 22-L, and 22-O were then voted on and <u>approved</u>. ("Yes" 52, "No" 14, "Abstain" 6)

Amendment 22-P was voted on and approved. ("Yes" 53, "No" 15, "Abstain" 3)

Third Poll: Honorably Retired 22-E. Committee recommendation was "no." This Amendment was rejected (53 voting "No", 11 voting "Yes", "Abstain" 2)

The Presbytery voted to extend the docket.

Call to Presbytery Stated Meeting May 6, 2023 Presbytery of San Jose

Fourth Poll: Twelve Week Family Leave 22-I. Committee Recommendation "no." After discussion, the Presbytery <u>voted rejection</u> of this Amendment. ("No" 34, "Yes" 30 and "Abstain" 4)

Because of time constraints, the rest of the scheduled Amendment votes were postponed to the next meeting of the Presbytery.

Church Health and Growth Work Group

The Rev. David Watermulder noted that this Group has started clergy conversations via Zoom, with the next conversations scheduled for February 28.

The Group still has Tech grants available with churches needing to upgrade tech for worship invited to apply. The form for this is online via the Presbytery web page. Grants are also available for help with the cost of Sabbaticals.

San Jose Hunger Advocate

The Rev. Ryan Althaus, reporting while riding his bicycle, gave information that he will be leading the next clergy discussion group, that the farm is fully open and functional, and that he would like to know about congregational hunger projects.

Peace and Justice Working Group

The Rev. Addie Domske reported from Washington State where she has moved to accept a call to ministry. (See Report, Appendix E)

Announcements

Information was given about the Presbyterian Conference Center at Zephyr Point, Lake Tahoe, with particular reference to a new camp for LGBTQ+; concerns about the PC(USA) Bible Exegesis Exam using Judges 19; a Trip to the Holy Land; a Messiah sing at Presbyterian Church of Los Gatos on Palm Sunday night; and a wall at Westminster, San Jose, honoring women in ministry.

Stated Clerk

The Rev. Erica Rader urged Presbyters to save the morning of March 16 for a visit from GA Moderator the Rev. Ruth Santana-Grace at the Presbyterian Church of Los Gatos, 9:30 to 11:30 am.

Adjournment

The Moderator called for a motion to adjourn; the Presbytery voted approval. The meeting was closed with prayer by Vice Moderator the Rev. Andy Rausch.

Appendix A

Coordinating Council of the Presbytery of San Jose

The Coordinating Council of the Presbytery met on January 12, 2023 at 6:30pm by Zoom

The Council is comprised of Chairs of committees, the most recent past Moderator, current Moderator, Moderator elect, chairs of Council subcommittees, moderator of PW and members at large. The role of the Council is to coordinate the life and ministry of the Presbytery in accordance with the policies, priorities and goals enacted by the Presbytery. The Council meets four times per year several weeks before Presbytery meetings and provides input on meetings to the Moderator and Stated Clerk.

Occasionally the Council will handle emergent business for the Presbytery or review information about current topics that affect the Presbytery.

The Council report includes information about the Council meetings and/or information that is not otherwise provided in a report of a Presbytery committee.

Presentation by Elder Ashley Gonzalez of Sunnyvale Presbyterian

Hardy Kim (Council member) introduced Ashley Gonzalez, Elder in Children's Ministries and a member of Sunnyvale Presbyterian Church's Land Use Exploratory Committee. She has 15 years' experience in architecture and development of public libraries and small local museums in the Boston area. Her firm won large remodeling grants for their clients by showing the worth of these facilities to their surrounding communities over time, even as they shifted to meet communities' changing needs.

Ashley leads a study (like asset-mapping) for the Sunnyvale committee that aims to understand the church's current patterns of use, and identify areas that can be bifurcated from the church and repurposed. Ultimately the committee's work will be to determine spatial allocation in the context of what the church wants to provide to the community.

The study is in its initial stages. Ashley developing a survey for Elders and Staff of Sunnyvale Pres. How have things happened before the pandemic, during the pandemic, how are they happening now, where do you want it to go next? Her first trial has already identified needs within her own area of ministry.

From the discussion:

 There are many ways a church can step up and use its land to serve the needs of its community.

- As a circle of opinion expands, expect conflicting and competing ideas, priorities, wishes and desires to arise. When it comes to land use, expect to encounter this both internally and with the community. Develop a plan to navigate competing and conflicting desires.
- How can council gain a sense of what our communities' overall priorities are, and how that might feed into helping Council make better decisions that are more responsive to their hopes and dreams and concerns? Would a survey of "people in the pews" be useful to the council?
- When thinking about asset-mapping in the presbytery, it's important to limit focus to only assets the presbytery controls, and to be clear about the goal of the study.

Polity and Government Subcommittee -- Erica Rader

Carol Holsinger has taken a sabbatical, a new chair is not yet designated but the Polity and Government Subcommittee will determine if one of their members wishes to serve as chair. Collette Lynner will be resourcing the subcommittee.

Regarding amendments to the constitution: while there are a number of amendments to consider, no special meeting will be called to review them; they will be considered at Feb 4 and May 6 meetings.

Stated Clerk Report – Erica Rader

The Presbytery fell victim to bank fraud. Two checks were stolen from the mail, both made out to a contractor. One was modified, presented for 55,000, and honored; a police report and an insurance claim has been filed to recover these funds. The insurance claim was approved by the claims adjuster and we will receive a check to compensate our loss.

Erica celebrates the Presbytery's Accountant, Diane Case, who caught the fraud and is managing the process of recovery: the fraud was discovered, and the Presbytery's exposure was limited, because Diane followed up on a check that didn't clear in a reasonable length of time. The affected bank account was closed, and stop payments placed on all outstanding checks. We have purchased new check stock with advanced security features and have established new procedures for large check amounts to avoid the US Postal service.

MY RETIREMENT

On April 13, I informed the Personnel Committee, the Coordinating Council of my decision to retire at the end of 2023. This August I will be 67-years-old, and I believe it is time for new leadership for the Presbytery of San Jose. This long advance notice is to give enough time for the presbytery to do necessary and appropriate work in the transition.

In January 2024 I will have been ordained as a Minister of Word and Sacrament for 38 years. In 1996 I was called as the Associate Executive Presbyter, and served for 12 years. In 2008 I was called as the Executive Presbyter, and have served for 15 years. I think it's time.

BEGINNING 2024

My last day will be December 31, 2023. I will still be living within the bounds of the presbytery, and will be seeking HR status, assuming that section in Book of Order has not changed. I will remove myself from any interaction with committees, working groups, and congregations of the presbytery. I will not attend Presbytery meetings, preach in any churches, nor take meetings with any pastors. The one exception I request is Sunnyvale Presbyterian Church, where my wife is a member and would like to attend worship with her. I will make myself available to the Stated Clerk and the transitional/interim Executive, as well as the next called Executive, only at their request. I hope to maintain this status for at least one year, longer if the Coordinating Council or the next Executive deems necessary.

I will continue in my capacity as chair of the Board of Directors of San Francisco Theological Seminary / University of Redlands, and on the Board of Directors of the Board of Pensions of the PCUSA.

IN GOOD HANDS

I am grateful for the opportunity to have served alongside two former Executives and three Stated Clerks. We currently have a wonderful staff team, in many ways the envy of other presbyteries. Recently I received a call from a pastor in a neighboring presbytery with a question regarding some requirements. I asked "why are you calling me and not your presbytery?" "Because I thought you guys would have figured it out and would know the answer." Collette and I (mostly Collette!) were able to help. Just like Diane and Edd help the Presbyterian Foundation with education and information and Erica helps co-moderate a special committee of the General Assembly. We have a great staff team.

Along with your excellent leadership on our committees, working groups and administrative commissions, the Presbytery of San Jose is in very good hands, remembering that ALL of us are in the hands of a loving God who ultimately holds each of us.

History of Evergreen Presbyterian Church

In March, 1983, fourteen adults and six children began meeting together with the hope of becoming a Presbyterian congregation in the Evergreen area of San Jose. They were gathered from the immediate neighborhood and other surrounding Presbyterian churches by the Presbytery to launch this new initiative in the developing east side of the City. The initial worship services were held in peoples' homes. Later, the group moved to Evergreen Valley College for Sunday morning services and Sunday School. The church was then officially incorporated on June 10, 1984. The Rev. Judy Walther was the organizing pastor who stayed with the church through June, 1987. There were sixty-eight charter members, with members of the Stearns family being the last remaining ones still with the church. Steve Morgan, a "Deacon On Loan" from Sunnyvale Presbyterian Church was also part of that original group and is still with us as a member.

In September of 1987, Rev. Art Dahlberg was then called as Evergreen's pastor and stayed through June, 1989. The Rev. Thomas Waddell was called in February of 1990 and stayed through June, 1992. Rev. Stephen Dietrich was ordained and installed in October, 1992 and stayed through April, 2003. Rev. Nancy Harrington was then called as a Stated Supply Pastor from September, 2003 through November, 2017. Rev. Dr. Jennifer Bales was then also contracted as a Stated Supply pastor in June, 2018 and stayed through Evergreen's closing in June, 2023.

A significant point in the church's history was the purchase of property on the corner of San Felipe and Fowler Roads. It was held by the Presbytery until Evergreen was able to raise the money needed to build a facility. The church's vision for ministry came out of a concern for their neighbors in Evergreen. There were plans in place to reach out through education, fellowship, and mission projects.

Unfortunately, EPC was never able to build due to cost prohibitive issues with the property, and the land was eventually sold during the time when Rev. Dietrich was pastor. This was a critical turning point for the congregation and could have led to their dissolution. However, they chose to stay together and found that they were still the Church, even though they couldn't claim real estate for themselves. It also meant they were able to focus solely on outreach projects without the burden of property maintenance. They dove into projects for the community which infused them with renewed energy in gathering for worship.

Being more nomadic in nature also gave Evergreen the upper hand during the recent pandemic. Transitioning from in-person services at the East Valley YMCA to Zoom was easier given there wasn't an attachment to a particular building. EPC knew from experience that the church is not defined by four walls, but rather the people.

In terms of projects, special relationships were formed over the years with Catholic Charities and their food distribution program, The Lord's Pantry at Gloria Dei Lutheran Church, the East Valley YMCA, Grail Family Services, Annette Hancock and Downtown Streets Team, Bridge Communities, as well as Devorah Duncan and her work with local school districts and migrant families. Evergreen's call to the community meant addressing issues of poverty, immigration, and education over the years. We became known for being the small church with generous hearts as we continually surprised people with thoughtful giving.

While we are deeply saddened that the Evergreen congregation has come to a close, we chose Pentecost Sunday as our closing date. We recognize that this is not an end, but a transition, as members will be sent out to other congregations and carry with them their faith experiences from their time at EPC. We know we will continue to make an impact for Jesus Christ in our Presbytery and in San Jose.

The Congregation of Evergreen Presbyterian church voted on March 12, 2023 to request that the Presbytery dissolve the congregation.

Brief Biography of Rev. Dr. Jim Raines

I was born on the south side of Chicago and became a Christian in high school. I attended Wheaton College where I double-majored in Christian Education and Biblical Studies. I received my B.A. and my M.A. there in 1975 and 1976. I then attended Fuller Theological Seminary and became a candidate for ministry at the First Presbyterian Church of Hollywood when Dr. Lloyd Ogilvie was senior pastor. Since I did not attend a Presbyterian seminary, I was advised by Presbytery of the Pacific to work in a Presbyterian church for two years prior to licensure. I became the Director of Christian Education at Silverlake Presbyterian Church when Dr. Peter Hintzoglou was the pastor. After licensure in June of 1982, I received my first call as Youth Pastor to a Presbyterian Church in suburban New Jersey, just outside of New York City. In that role, I encountered social problems such as alcoholism, child abuse, domestic violence, and teen suicide, so I decided to obtain my M.S. in Social Work from Columbia University, where I met my wife, Ottie. I worked in social services for a large Catholic agency (Good Shepherd Services) and got married in 1990.

We moved to Chicago and I became a supervising social worker and adjunct instructor for Loyola University until 1994. In 1995, I was given a full scholarship to pursue my PhD in social work and began teaching social work as well as a course in the Bible as literature at Aurora University and serving as the university chaplain. During this time, I served as Parish Associate for the First Presbyterian Church of Aurora, teaching the college-age Sunday school class and occasionally preaching as needed.

In 2002, we moved to Bloomington, IL to work for Illinois State University. Due to internal tensions (the Senior Pastor had been charged with domestic violence) within the local Presbyterian church there, we chose to attend an Evangelical Free Church where I taught the adult Sunday school class for 8 years, trained small group leaders, and preached as needed. In 2010, I was offered an administrative position at California State University Monterey Bay as the department chair for Health, Human Services, and Public Policy. During the time that my youngest child lived with us, we attended Shoreline Church where Kevin Harney is pastor (another Fuller grad). After this, we attended the First Presbyterian Church of Salinas until they left the Presbytery to become an independent, nondenominational church. We then began exploring other Presbyterian church including the ones in Carmel and Monterey. In January of 2021, we started attending Lincoln Ave. Presbyterian Church where we have worshipped ever since. I preached my first sermon there on October 9, 2022 and was asked to consider becoming a parish associate.

NOTES and EXPLANATIONS FOR THE 2022 STATEMENT OF FINANCIAL ACTIVITY

- 1 STATEMENT OF FINANCIAL ACTIVITY, the Profit and Loss, lists the revenue (income) and the disbursements (expenses) of the organization for the last fiscal year, excluding the purchase of property.
- 2 MISSION/PROGRAM Budget, the revenues come from the Basic Mission Giving of our congregations with some assistance from Presbytery investment income and supports the general mission staff and programs of the Presbytery.
- 3 **ECCLESIASTICAL Budget**, the revenues come from the Per Capita of our congregations with some assistance from Presbytery investment income and growth and supports the operations of the Presbytery.
- 4 REVENUES, the income of the Presbytery is divided into broad categories for ease of understanding.
- 5 PER CAPITA, this is the Presbytery's portion of the amount paid by the individual congregations based upon the number of members on their roles at the time of the previous year's report. Goes to fund the Ecclesiastical Budget.
- **CONGREGATIONAL MISSION**, this is the Presbytery's portion of the Basic Mission Giving from the churches of the Presbytery. Goes to fund the Mission Program budget.
- 7 **POOLED INVESTMENT**, this includes the interest, dividends, and unrealized growth or loss from Presbytery's investment pool which are used to help fund the budget of both the Mission and Ecclesiastical Program.
- 8 SYNOD AND GA FUNDING, Synod of the Pacific has extra income from their Savings and Loan program, and they share some of their excess with each of the Presbyteries in the Synod. There are a few endowments set up at the Synod (Anne Penke) and the GA (Walker, Miesse) that send income to our Presbytery. Additionally, some of our revenue comes from GA funding for programs like Hunger and Peacemaking.
- 9 IMMANUEL HOUSE, this is pass through income sent by churches through the extra commitment giving program of the Synod and is passed on to the IH Board for their use in the mission of transitional housing for refugees.
- 10 CORNERSTONE RENT, Cornerstone church pays the equivalent of their share of the cost of insurance, taxes, maintenance, and utilities for the Meridian Way property.
- 11 DISMISSAL FUNDING, these funds are the interest (4%) on the dismissal money used for various Community Mission Projects, Congregational Renewal Projects, and Per Capita Assistance. (30,000 each) Congregations and elders can apply for these funds for use in Mission and Renewal projects within the Presbytery.
- 12 DISBURSEMENTS, the expenses of the Presbytery are divided into three areas based upon our vision statement. We are seeking to build connections between churches and the community, we are seeking to provide needed resources to congregations, and we are seeking to help individual ministries as well.
- 13 CONNECTIONS, the various ways the Presbytery supports congregations and their work of ministry to the communities where we live.
- 14 PER CAPITA, GA AND SYNOD, this is our annual assessment paid to the GA and Synod.
- 15 JUSTICE AND MISSION, this line includes the budgeted expenditures of the Mission and the Peace & Justice task forces.
- 16 RESOURCES, ways we are resourcing congregations for greater effectiveness.
- 17 SCHOLARSHIPS, these scholarships are available for adults and youth from the churches of the Presbytery for camps, conferences, and further religious education.
- 18 VISION GRANTS/CHURCH GROWTH, we have a variety of grants available for projects at our churches to improve the quality of the church's program and ministry.
- 19 TRANSITIONAL MAINTENANCE, these are a few expenses incurred this year to work with the closing of facilities at Watsonville Main, and setting up plans for the future.
- 20 OTHER PROJECTS, including the resources of Representation and Empowerment, Stewardship Training, the Media Center support, COM and CPM committees, Emergency Assistance, and the like.
- 21 MINISTRIES, mobilize (Assist) relationships between Teaching and Ruling Elders within the bounds of the Presbytery so we can work together for the greater good of the Kingdom of God.
- 22 STAFF AND BENEFITS, providing the Exec Presbyter, Stated Clerk, Office Manager, Accountant, and Treasurer to help the ongoing work of the Presbytery.
- 23 OFFICE AND FACILITIES, carrying on the work of the Presbytery including supplies, equipment, payroll services, auditing, insurance, utilities, etc.

NOTES and EXPLANATIONS FOR 2022 STATEMENT OF FINANCIAL POSITION

- 1 STATEMENT OF FINANCIAL POSITION, the Balance Sheet, does not indicate anything related to income and expenses but summarizes the assets (holdings) and liabilities (obligations) of the Presbytery.
- 2 MISSION/PROGRAM, this column includes the locations of the assets owned by the Presbytery directly related to the Mission/Program budget.
- 3 ECCLESIASTICAL PROGRAMS, this column includes the locations of the assets owned by the Presbytery directly related to the Ecclesiastical/Program budget.
- 4 ASSETS, the assets are defined as any real asset, like a bank account, the value of investments, the book value of real property, and the like.
- Cash Accounts, these monies are in bank and savings accounts and in "demand" accounts at the Synod. They are to help meet the short-term obligations of the Presbytery, i.e., day-to-day cash flow.
- 6 Bank & Savings Accts, show the total balances of various bank and savings accounts, located at Bank of the West at year end.
- 7 Synod Cash Accts, are the balances of various deposits with the Synod of the Pacific in Custodial Funds that receive interest. These include accounts where the money is deposited "on demand" just like a savings account.
- 8 Investment Accounts, these accounts include longer term investment (MDCs) available through the Synod, mutual funds, ETFs, Bonds, and some additional investments.
- 9 **Synod (MDC) Accts,** are similar to CDs which pay a higher rate of return depending on the length of time the money is invested. This is a product of the Synod of the Pacific; and is available to Presbyteries and local churches in the Synod but not to individuals.
- 10 Presbyterian Foundation (NCF) Accts, are mutual funds invested by the New Covenant Funds. The Growth fund invests in stocks of the S&P 500 companies according to the Socially Responsible guidelines of the General Assembly. The Income Fund includes government bonds and similar fixed income opportunities. You can see information about these investments on their website; NewCovenantFunds.com
- Brokerage Acct, The Stock portion of the Brokerage account is invested in S&P 500 vehicles SPY (general S&P 500 stocks), SPYX (general S&P without Carbon 200 companies), and SUSA (general S&P stocks with high commitment to ESG protocols). The Bond portion of the Brokerage account is invested in a variety of corporate bonds available on the open market; laddered out over an 6-8-year time horizon.
- 12 **Credit Lines Outstanding,** in certain extraordinary circumstances the Presbytery has loaned monies at interest for specific projects that seemed beneficial. Presbytery encourages churches who are looking for loans to take advantage of the Synod Loan Program and their various different interest rates and loans.
- 13 Fixed Assets, this includes property assets that are real property, owned in the name of the Presbytery alone, not in conjunction with individual churches.
- Real Estate, The Presbytery owns the property known as the Immanuel House, operated by the Immanuel House Board for transitional refugee housing; the property at Meridian Way where the offices are located, and Cornerstone Church currently resides; the property on Beach Street in Watsonville, the property on Main Street in Watsonville; the property on Mental Ave in Santa Cruz and the Catamaran purchased by donations to the Sweaty Sheep NWC. These properties are listed at book value less the accumulated depreciation. Note: Book Value means the price originally paid for the property plus substantial improvements.
- 15 LIABILITIES, the liabilities show how much of the assets are allocated to specific projects. For example, your home bank account might have \$5,000 in it. But some of that money is specifically earmarked for the upcoming insurance payment and future property taxes so you cannot spend all of the money in the checking account. The Presbytery has obligations as well.
- 16 **Restricted Funds** have been set aside for specific projects, with the expectation that they will be used in the future for those purposes or reallocated to other projects. All of the restrictions were set by a vote of the Presbytery and can be adjusted at anytime by a vote of the Presbytery.
- 17 **Special Funds** set aside, usually, from unspent budgeted items, to pay for programs in the future, like the Youth Triennium, Camperships, Christian Education projects, Cong. Development, Representation, Justice & Mission, COM projects, and other ministries of the Presbytery.
- Scholarship Funds, the proceeds of these funds, primarily coming from the sale of the Corralitos Camp property (1990 time frame) and set aside at the time by a vote of Presbytery, generate income for scholarships for people within the Presbytery to attend camps and conferences.

- 19 **Evergreen Funds,** this is money from the sale of their church property and is managed by the Presbytery and the income is used to help the Evergreen church with some of its ongoing expenses.
- 20 Reserve Fund, with an ongoing combined Mission Program and Ecclesiastical Program Budget of 750,000, the reserve monies are designed to produce enough Return on Investment (ROI) to cover approximately 1/4 of the annual budget if so needed.
- 21 **Cypress Ave. Funds** came from the sale of the Cypress Ave Property and were set aside at the time by the Presbytery for Korean American ministries.
- 22 **Dismissal Receipts to date**, these funds have come from the settlement agreements of the dismissal of churches in our Presbytery. The proceeds of these investments will fund per capita, community mission, and congregational renewal through grants to churches in our Presbytery. See the criteria and the application forms under the Financial Affairs Committee on the Presbytery website; sanjosepby.org.
- 23 UP Watsonville, these are monies set aside for the commission at UPC Watsonville
- Urban Ministry San Jose, these are monies set aside for the work of the commission related to San Jose First church property sale and future ministry. Currently being used to refurbish the school building on the property of Westminster Presbyterian Church in San Jose to be rented by the Bill Wilson Center for increasing their work to at risk youth in the greater San Jose area.
- 25 Office Operations, these monies are available for expenses related to the office of the Presbytery.
- 26 **UnRestricted Funds,** these include the value of properties of the Presbytery, and cash equivalents that have not been earmarked for a particular purpose or project at the moment.
- 27 Real Estate, see item 14 above for a list of the properties.
- 28 **Cash Equivalents**, this money could be allocated in the future for various projects, however, in the meantime they help generate the income of the portfolio for the benefit of the ongoing budget and the future vision of the Presbytery of San Jose.

Financial Affairs Committee Report

Financial Affairs Committee (FAC) has reviewed and approved leases for Westview PC, Gilroy PC, and Stone Church of Willow Glen. We are preparing a Frequently Asked Questions document to help churches understand the purpose and the process of lease approvals by the Presbytery and/or this committee.

We reviewed and discussed monthly the Presbytery budgets vs actuals and changes in the investment portfolio.

We met with a representative of Westminster to discuss their need / timing for a line of credit until their Synod load payments can be made, and agreed to a \$40,000 line. Repayment of any outstanding balance will begin once rental income starts on the Downtown Commission project (San Jose Urban Ministry).

We continue to be engaged with Santa Cruz Urban Works (formerly Sweaty Sheep) in several conversations about ministry opportunities in the Santa Cruz area, and have advised on their discernment process.

We discussed and advised Evergreen Presbyterian Church on managing their cash flow through their dissolution process.
