2024 Financial Statements and Treasurer's Report, Diane Case, Accountant and Rev. Edd Breeden, Presbytery Treasurer

In this year's report the Mission and Ecclesiastical budgets are combined. 2024 annual reports are included in this docket, along with notes to define terms. Edd and Diane's presentation summarized reports in **APPENDIX E**.

- 2024 draw from investments: 4.6%, \$451K
- 2025 draw from investments is anticipated to be 8%.
- A "Comprehensive Assessment of Faithful Stewardship" is planned in 2025 for projects sponsored by the Presbytery: Watsonville AC's Watsonville Public House and Somos; San Jose AC's Urban Ministry; Urban Works, and Sweaty Sheep, will be conducted by a group approved by Coordinating Council.

Polity & Government, Rev. Bryan Franzen

Amendments to the Constitution

Action. Presbytery *ratifies* the proposed amendments to the constitution: 24-A, 24-B, 24-D, 24-F, 24-H, 24-I, 24-J, 24-M, 24-E, 24-G.

Action. Presbytery *disapproves* Polity and Government's recommendation to deny ratification of 24-K and 24-L.

Action. Motion from floor to ratify 24-K *does not have a clear majority in favor*. Mark Peake brings point of order: no discussion was allowed before the vote.

Action. Presbytery *rejects* proposed amendment to the constitution: 24-C.

Safe Church Policy

Bryan Franzen reports that the Polity and Government subcommittee has taken up the project of creating a common set of rules for churches to follow regarding child sexual abuse prevention. The subcommittee plans to have a lawyer review how new CA state laws affect the presbytery. Expect news on directives from the Presbytery in early 2026.

Report to Presbytery February 27, 2025
(covering December 2024 – February 2025 activities)

Items for Docket:

Second reading and proposed adoption of Policy and Program for Commissioned Ruling Elders (CREs) (**First Reading was November 2024, see draft minutes in docket pp. 16-34**)

Information Items:

1. COM finalized the proposed Policy and Program for Commissioned Ruling Elders (CREs) on November 11, 2024, and presented it to the Presbytery for a first reading on November 23, 2024.
2. At a November 25, 2024 special meeting, COM voted to dissolve the pastoral relationship between Rev. Joe Park and El Estero Presbyterian Church. This action was taken after extensive attempts to resolve significant issues between Rev. Park and the El Estero session and much prayerful consideration. COM has been providing session moderator services and working with El Estero to arrange for pulpit supply.
3. On December 9, 2024, COM finalized a new Pastoral Support for Pastors program to provide peer support to pastors undergoing challenging personal issues. (See Attachment A.)
4. Rev. Diane Ford was installed as Pastor of Trinity Presbyterian Church of Santa Cruz on January 5, 2025.
5. COM approved the following agreements:
 - a. Stated Supply Associate Pastor contract between Rev. Neneth Ross and Westminster Presbyterian Church.
 - b. Stated Supply Pastor contract between Rev. Jason Barraca and Lincoln Avenue Presbyterian Church.
 - c. Parish Associate agreement between Rev. Jim Raines and Lincoln Avenue Presbyterian Church.
 - d. Stated Supply Pastor contract between Rev. Annanda Barclay and Sunnyvale Presbyterian Church.
6. Reminders:
 - a. The Minimum Terms of Call were updated effective January 1, 2025 to reflect the 2.5% social security COLA. The new minimums are: Santa Clara County \$117,857; Santa Cruz County \$98,770; Monterey County \$72,324.
 - b. Several Teaching Elders still have not completed the required Boundary Training. This training is very important and COM will not consider waivers. COM will work with the Stated Clerk to identify training options for people who could not attend the Presbytery's 2024 training sessions and will circulate this information.

COM ATTACHMENT A

Presbytery of San Jose Peer Support Program
(Approved by Committee on Ministry December 9, 2024)

Purpose: Pastoral Care for Pastors - preparing a list of volunteers willing to provide pastoral care for other pastors in the Presbytery, particularly those undergoing difficulties, such as serious illness, divorce, loss of a loved one, etc.

Rationale: When pastors go through difficult personal crises, they often have no one to turn to for pastoral care for themselves (or their families). This proposal would provide a way for volunteer peer support pastors to fill this role on a temporary basis. This proposal would provide pastoral care for pastors in our Presbytery. It is not meant to replace therapy or other professional consultation of any kind. It is simply accompanying a colleague in crisis in a caring way as an impartial third person.

What is expected of pastors who agree to be peer support

Basically the peer supporter would function as a pastor to another pastor in crisis. What would be appropriate to offer to a parishioner in terms of pastoral care would generally be appropriate to offer to one's colleague in this relationship. The main role of peer support would be to accompany a colleague through a difficult time, such as, but not limited to:

- major illness (self or family member)
- mental illness (self or family)
- loss of a loved one
- divorce

This support could include, but is not limited to:

- prayer or other spiritual care; being present
- active listening, validating emotions
- limited pastoral counseling (no more than three sessions)
- assisting in assessing what resources are needed (such as therapists or other professionals, depending on the circumstances)
- assistance with finding those resources (from the EAP or other providers)
- arranging for practical help such as meals, rides to the doctor, etc. on a limited basis. Assisting with identifying persons from the counselee's church or others who could help if the needs are on-going.

COM ATTACHMENT A

It could include similar ministry to the counselee's spouse or family, if mutually agreed upon. (If the spouse or family member requests pastoral care, a separate person could be assigned, to avoid over-burdening any one pastor.)

The peer support does NOT include therapy or other psychological or psychiatric counselling; medical or legal advice, or other professional advice which the peer supporter is not qualified to give.

Relationship boundaries –The same or similar boundaries observed in pastoral counseling relationships should be observed.

How to Initiate a Peer-Support Relationship:

- 1) The person in need of support may contact the Stated Clerk of Presbytery or the Executive Presbyter for a recommendation; or
- 2) The person in need of support may contact a colleague from a list provided by the Stated Clerk or Executive Presbyter; however, the person must notify either the Stated Clerk or E.P. that a peer support relationship is being initiated and with whom.

It is recommended that a general reason be given, but details are not required.

Resource Persons – two or three qualified persons in the Presbytery will be available for consultation, should the peer supporter feel in need of advice, expertise, or has a question about observing proper boundaries. Rev. Libby Boatwright has offered to help with this. Executive Presbyter Rev. Dr. Neal Presa and Rev. Erica Rader are also available.

Accountability: The Executive Presbyter will keep track of these relationships. This task may be delegated to the Stated Clerk, but not to anyone else, for reasons of confidentiality.

Review, Renewal, or Termination of Peer Support Relationship: This relationship should not extend more than three months without being renewed by mutual agreement. It may be renewed at three-month intervals, until the crisis has passed, or the person is no longer in need of peer support. At the end of each three-month period, the peer supporter will hold a brief conversation with the executive presbyter or stated clerk, to report briefly on how things are going, without violating any confidences. If there are any concerns the decision may be made to terminate the relationship. Otherwise, it is up to the peer supporter and the person being supported to decide to terminate the relationship (officially) and inform the appropriate Presbytery officer.

The Financial Affairs Committee met in early December, January, and February. We approved several leases for congregations to rent out their spaces as well as a loan application from Westminster to the Synod for an HVAC to the congregation's manse. We also approved a policy that the presbytery will pay grants and reimbursements to congregations using ACH payments because these are more secure and easier for auditing purposes. Finally, we reviewed the year-end financial reports for the Presbytery. We are working to clarify how we report information to the presbytery so that it is the most transparent and easiest to understand. We hope these improvements can help all commissioners understand and review our financial status more effectively.

We encourage congregations to approach financial affairs regarding questions they may have about leasing out their spaces and loan applications.

NOTES and EXPLANATIONS FOR THE 2024 FINANCIAL REPORTS OF THE SAN JOSE
PRESBYTERY

BUDGETED FINANCIAL STATEMENT, lists the revenue (income) and the disbursements (expenses) of the organization for the last fiscal year.

INCOME, the income of the Presbytery is divided into broad categories for ease of understanding.

PER CAPITA, this is the Presbytery's portion of the amount paid by the individual congregations based upon the number of members on their roles at the time of the previous year's report. The total Per Capita is paid through the Synod and is then divided amongst the General Assembly, the Synod, and the Presbytery.

SYNOD BLOCK (Partnership) Grant, this is the Presbytery's portion of the Basic Mission Giving from the churches of the Presbytery and from a portion of the income from the Synod investment program.

ANNIE PENKE FUND, is an endowment fund set aside by Annie Penke with the proceeds going to mission work being done in our Presbyter and three other Presbyteries of the Synod.

FOUNDATION FUNDS, various families (**Walker, Lundy, Miesse, and Davies**) have placed money in endowment with the Presbyterian Foundation to benefit the Presbytery of San Jose.

GA FUNDING, some of our revenue comes from GA funding for programs like **Hunger and Peacemaking**.

IMMANUEL HOUSE, this is pass through income sent by churches through the extra commitment giving program of the Synod and is passed on to the IH Board for their use in the mission of transitional housing for refugees.

CORNERSTONE RENT, Cornerstone church pays the equivalent of their share of the cost of insurance, taxes, maintenance, and utilities for the Meridian Way property.

INTEREST AND GAINS/LOSS, this includes the interest, dividends, and realized growth or loss from Presbytery's investment pool which are used to help fund the budget.

INVESTMENTS SUBSIDIES, these funds come from the proceeds of the investment portfolio of the Presbytery.

EXPENSES, the expenses of the Presbytery are divided into categories of spending.

MINISTRY, the many different programs of the Presbytery.

GRANTS, the three types of grants available to congregations, for vision ideas, mission programs, church health projects. Applications are available on the Presbytery website.

PROPERTY, these include various expenses related to the insurance, taxes, maintenance, and expenses of the various properties owned by the Presbytery.

PER CAPITA, annual apportionments to the General Assembly and the Synod based upon the membership of the Presbytery to jointly fund the programs of these regional and national organizations of our church.

GENERAL ADMINISTRATION, the various operational expenses of the Presbytery office including annual legal and or audit expenses.

PERSONNEL, providing the Exec Presbyter, Stated Clerk, Office Manager, Accountant, and Treasurer with salaries and benefits to help the ongoing work of the Presbytery. This category also includes various advocates hired by the Presbytery for helping the congregations with hunger, peacemaking, safe church, and other communications of the Presbytery.

STATEMENT OF FINANCIAL POSITION, the Balance Sheet, does not indicate anything related to income and expenses but summarizes the assets (holdings) and liabilities (obligations) of the Presbytery.

ASSETS, the assets are defined as any real asset, like a bank account, the value of investments, the book value of real property, and the like.

CURRENT ASSETS, these monies are the yearend balances in bank and savings accounts currently held at Chase bank.

INVESTMENTS

SYNOD CASH ACCT, the yearend balance of monies held at the Synod on deposit. From time to time these monies might be invested in MDCs at the Synod for longer term interest rates. Currently the monies are deposited "on demand" just like a savings account.

FOUNDATION, are mutual funds invested by the New Covenant Funds. The Growth fund invests in stocks of the S&P 500 companies according to the Socially Responsible guidelines of the General Assembly. The Income Fund includes government bonds and similar fixed income opportunities. You can see information about these investments on their website; NewCovenantFunds.com

BROKERAGE ACCOUNT, The Stock portion of the Brokerage account is invested in S&P 500 vehicles SPY (general S&P 500 stocks), SPYX (general S&P without Carbon 200 companies), and SUSA (general S&P stocks with high commitment to ESG protocols). The Bond portion of the Brokerage account is invested in a variety of corporate bonds available on the open market; laddered out over a 6-8-year time horizon.

NOTES AND LINES OF CREDIT, in certain extraordinary circumstances the Presbytery has loaned monies for specific reasons that seemed beneficial to the work of the Presbytery. Presbytery encourages churches who are looking for loans to first take advantage of the Synod Loan Program and their various different interest rates and loans.

FIXED ASSETS, this includes property assets that are real property, owned in the name of the Presbytery alone, not in conjunction with individual churches. The Presbytery owns the property known as the property on Mental Ave in Santa Cruz currently used by Trinity Presbyterian as a manse for their pastor, the Catamaran purchased by donations to the Sweaty Sheep NWC, the property on Main Street in Watsonville being used as the Watsonville Public House, the property at Meridian Way where the offices are located, and Cornerstone Church currently resides, the Immanuel House, operated by the Immanuel House Board for transitional refugee housing. These properties are listed at book value less the accumulated depreciation. Note: Book Value means the price originally paid for the property plus substantial improvements. Historical properties that have been fully depreciated are not listed on the balance sheet.

LIABILITIES, the liabilities show how much of the assets are allocated to specific projects. For example, your home bank account might have \$5,000 in it. But some of that money is specifically earmarked for the upcoming insurance payment and future property taxes so you cannot spend all of the money in the checking account. The Presbytery has obligations as well.

SPECIAL FUNDS, have been set aside for specific projects, with the expectation that they will be used in the future for those purposes or reallocated to other projects. You can see the various different designations that have either come from unspent budgeted items, to pay for programs in the future, like the Youth Triennium, Camperships, Christian Education projects, Cong. Development, Representation, Justice & Mission, COM projects, and other ministries of the Presbytery. The **Cypress Fund** came from the sale of the Cypress Ave Property and were set aside at the time by the Presbytery for Korean American ministries. **Watsonville Commission**, these are monies set aside for the commission at UPC Watsonville. **St Philips Main St.** are funds from the sale of the St Philips property in the city of Salinas. All of the restrictions were set by a vote of the Presbytery and can be adjusted at any time by a vote of the Presbytery.

OPERATING FUNDS, and **RETAINED EARNINGS** are accounting terms to help make the Assets and the Liabilities Balance. Although it appears the Presbytery has a large value of assets you will notice that much of that value is related to the investment value of the property. To calculate the working investment assets of the Presbytery at the end of 2024 you would need to take the Total Investments of 7,595,272.09 and subtract the Special Funds set aside in the Liabilities of 2,984,707.33. The working assets of investments (4,610,564.76) affords the Presbytery the assurance that we can continue to operate at the current level

**Policy and Program for Commissioned Ruling Elders (CREs) for the
Presbytery of San Jose**

Purpose

The purpose of this policy is to outline the roles, responsibilities, education, and accountability measures for Commissioned Ruling Elders (CREs). This policy aims to ensure that CREs are well-prepared for their ministry and accountable in their service to the church and community.

Scope

This policy applies to all individuals serving as Commissioned Ruling Elders within The Presbytery of San Jose.

Definitions

- **Commissioned Ruling Elder (CRE):** A ruling elder who is commissioned by the Presbytery to serve in a specific pastoral role within a congregation or in a validated ministry.

Role and Responsibilities

CREs are commissioned to perform specific pastoral duties which may include:

- Leading worship and preaching.
- Administering sacraments.
- Providing pastoral care.
- Moderating session meetings.
- Engaging in community outreach and mission activities.
- Performing administrative duties as assigned by the session or Presbytery.

Oversight

The CRE policy and program will be under the oversight of a newly established CRE Subcommittee of the Committee on Ministry (COM). The Subcommittee will also have at least two representatives from the Committee on Preparation for Ministry (CPM).

Committee on Ministry Second Reading

Education Requirements

To ensure that CREs are well-prepared for their ministry, the following educational requirements are recommended. The specific requirements will be determined in consultation with and approved by the CRE Subcommittee.

1. **Theological Education:** CREs should complete a course of study in Reformed theology, Bible, preaching, worship, sacraments, pastoral care, PC(USA) polity, and church history. This can be accomplished through a seminary, approved lay training programs, or other Presbytery-approved educational institutions.
2. **Practical Training:** CREs should participate in practical training opportunities, such as internships, supervised ministry experiences, and workshops on pastoral skills.
3. **Continuing Education:** CREs are encouraged to engage in ongoing education through attending conferences, seminars, and additional coursework to stay current with theological and pastoral developments.

Procedure

1. **Discernment and Nomination:** Potential CREs are identified and recommended by their session and must undergo a period of discernment. Following discernment, the session may nominate the individual to undertake the CRE process.
2. **Training:** Applicants must complete the required education and training, and pass an examination by the CRE Subcommittee covering theology, Bible, PC(USA) polity, and pastoral skills.
3. **Examination:** When the CRE Subcommittee believes the Applicant is ready to serve in a specific pastoral role within a congregation or in a validated ministry, it shall make a recommendation to the COM. COM shall interview the Applicant and, if it agrees that that the Applicant is prepared for the particular CRE role, it will deem the Applicant ready for commissioning and report this action to the Presbytery.
4. **Commissioning Service:** Upon favorable recommendation by COM, the church or other organization for which the Applicant will be serving as a CRE will conduct a commissioning service to formally commission the individual as a CRE

Accountability

To maintain high standards of accountability, the following measures are implemented:

1. **Supervision and Support:** CREs will be assigned a mentor or supervisor by the CRE Subcommittee, typically a teaching elder or experienced ruling elder, who will provide

guidance, support, and supervision.

2. **Regular Reporting:** CREs are required to submit regular reports to the session and Presbytery (through the CRE Subcommittee) on their ministry activities, challenges, and achievements.
3. **Performance Reviews:** The Presbytery (through the CRE Subcommittee) will conduct annual performance reviews to assess the effectiveness of the CRE's ministry and identify areas for growth and development.
4. **Code of Conduct:** CREs must adhere to a code of conduct that includes maintaining confidentiality, demonstrating ethical behavior, and upholding the values and doctrines of the Presbyterian Church (USA).
5. **Conflict Resolution:** A clear process for addressing conflicts, grievances, and disciplinary issues involving CREs will be established by the Presbytery (through the CRE Subcommittee or the COM).

Review and Renewal

1. **Term of Service:** CREs are commissioned for a specific term, typically renewable every three years, subject to a review by the Presbytery.
 2. **Recommissioning:** At the end of each term, the Presbytery will conduct a comprehensive review of the CRE's ministry before deciding on recommissioning for another term.
- ### Role and Status at Presbytery Meetings

The parity of ruling elders and teaching elders in the life and governance of the governing bodies of the Presbyterian Church (USA), specifically, and in the Reformed traditions, generally, is a significant and essential theological expression of what it means to be a church which dignifies the "priesthood of all believers" and the gifts of all of God's people. It is understood that: (1) only a CRE who is functionally serving in a congregational ministry as pastor/head of staff, or (2) who is a ruling elder commissioner from a session to Presbytery, shall be accorded the right and privilege of voice and vote in Presbytery. For all other CREs, they shall be accorded the privilege of voice only in Presbytery; such privilege shall be accorded for the duration of their active commission.

Conclusion

The role of a Commissioned Ruling Elder/Commissioned Pastor is vital to the ministry and mission of the Presbyterian Church (USA). By adhering to this policy, we ensure that CREs are well-prepared, supported, and held accountable in their service to God and the church community.

Commissioned Ruling Elder (CRE) Equipping Program



Steps Paper and Forms for becoming a CRE

A Helpful Timeline for the process of becoming a Commissioned Ruling Elder to Particular Pastoral Service (known as **Commissioned Pastor** or CP in The Book of Order)

Presbyterians are known for doing things “Decently and in Order” and doing much of their work in committees. This does support a democratic and fair procedure but can make our processes sometimes feel long and arduous. We have prepared this CRE time-line to help those wanting to navigate the process better by understanding important deadlines and anticipate how long each step in the process may take.

Following are *estimated times* required for each of the steps in the process.

- As you begin the process, you will have to work with your Pastor and Session to have forms CRE Application Forms 1A, 1B & 1C filled out. Since most Sessions only meet once a month, you will need to work with the Pastor to get on the Session docket. Plan on this taking ***about 2 months***.
- After the meeting with the Pastor and Session, you should follow up with them to make sure they have turned in the forms to the CRE Subcommittee of the Committee on Ministry (COM) through the Executive Presbyter.
- After you submit your application forms (*Forms CRE-1A, B & C*) to the CRE/CP Subcommittee they will assign you a liaison. The liaison will work with you and your congregation during this process. You should be contacted by your liaison shortly after that person is assigned.
- Also at the start of your program you will need to work with your liaison and supervisor to begin to envision the details of what specialized ministry(s) you are being set aside for and to determine your plan of study (*Planning Forms CRE-2A and 2B*).
- When you have finished all your required class work, you will work with your liaison to schedule a time for examination by the CRE Subcommittee. **One month before** this meeting you will need to send in your Commissioning Forms: Brief Statement of Faith, Biographical History, *Commissioning Approval Forms CRE-3A, 3B, and 3C*), along with Continuing Development Form 4A.

Because the CRE Subcommittee is a subcommittee of the Committee on Ministry, all their actions must be approved by COM (which meets once a month). Because of when these groups meet and the lead time to get on dockets, it takes ***at least 3 months*** (longer during summer and holidays) to complete the process of approving you as CRE after your examination. You need to consider this when planning the Presbytery service of worship when you will be commissioned.

- You need to attend the COM meeting where you will be approved as a CRE. COM's approval will be included in the COM next report to Presbytery, so you will most likely be introduced to the Presbytery, either by video or in person.

If you add up all the times outlined here you can see that the CRE commissioning process from start to finish can take **18 months and longer** depending on when you start the program and how much time you can give to the work involved. Though this might seem long it is really a very good season to discern your call and work with others in helping you shape your call to CRE ministry as you prepare for this important work.

We encourage you to be creative and let “you” shine through. We want your statement to be personal, to clearly be your own, not to be trite or a “cookie cutter” Statement of Faith. That being said, below are a list of topics you should include.

The CRE Subcommittee, your liaison, your supervisor, and your support network will help you look at your statement of faith and make suggestions where needed. Your one-page Statement of Faith and your one-page biography (a separate document) will be included with the documents that go to the Committee on Ministry when your commissioning is approved.

Here are some topics that you should include.

- The Trinity
- God
- Jesus Christ
- The Holy Spirit
- The Bible
- The Church, its nature and mission
- Sin/brokenness
- Forgiveness/Reconciliation
- Salvation
- The Sacraments
- Eschatology – that part of theology concerned with death, judgement, and the final destiny of the soul and humankind, the in-breaking of God’s promise in the present

These topics can be woven into others and don’t have to be fully examined. Lean on us as needed with developing your brief statement of faith.

Review of NEAR II Gathering September 6, 2025 at First Mountain View

Council members reviewed the meeting, which was deemed to be engaging, informative and inspiring. In particular, our speaker Mark Labberton's was praised for his wisdom about being faithful in our current times and the lively panel discussion was deeply appreciated. Deb Troester's facilitating of the panel was skillful and everyone was engaged by the panel dialogue between Julie Center and Bill Wilson center's Josh Selo. We were grateful to commission our first CRE, our vice moderator Tim Parmentier.

Moderator Libby Boatwright's leadership and coordination in the implementation of the NEAR gathering was key to this successful event.

Stated Clerk, Erica Rader

Erica Rader has notified the Coordinating Council of her decision to resign as Stated Clerk effective February 28, 2025. She is very grateful for her 8 years of ministry as Stated Clerk and she is appreciative of the kind words of affirmation and support as she makes this decision. She has great confidence in the wonderful leaders of the Presbytery and trust that God will call the right person to replace her. She is also confident in the energy and love that our EP Neal Presa has demonstrated in his care for the Presbytery.

Task Force for the Presbytery's Properties and Affiliated Non-profits

Moderator Libby Boatwright has been authorized by Coordinating Council to appoint members of a task force to address the ministry, strategic direction and connectional opportunities of our affiliated non-profits. She has been inviting participants. This Task Force will report to the Coordinating Council and any necessary actions will be brought to the Presbytery.

The Task Force's role will be to examine the affiliated non-profit entity's relationship with the Presbytery, the affiliated non-profit entity's policies and practice, history of collaboration with other ministries and congregations of the Presbytery, its program effectiveness and future strategies. The Task Force will review relevant documents, publications of the affiliated non-profit entity to gain a better understanding of the entity. It will visit with the affiliated non-profit entity and talk personally with staff and the governing board. The Task Force is to conduct its work within the context of the Presbytery's concern for the strong vital connections with and within the Presbytery and the whole church. The governing board of the affiliated non-profit entity is responsible for the internal management of the entity and its operational details. The Task Force's role is to strengthen the bonds of the affiliated non-profit entity to the Presbytery, the essential mission of the Gospel, and the basic accountability of the governing board and staff of the affiliated non-profit entity to the Presbytery.

The Task Force should celebrate with the Presbytery the successful ministries of the affiliated non-profit entity it is reviewing. The Task Force will report to the Coordinating Council.

The Working Group on Committee on Representation and Empowerment (CORE)

Coordinating Council received the attached report (Appendix A) from the Working group. Based on this report, the Coordinating Council took the following actions:

Action: Recommend to Presbytery:

Establish as a strategic vision/direction for the Committee on Representation and Empowerment (CORE) for 2025-2027 to act as a principal body of the Presbytery focused on connecting with, resourcing, and empowering our congregations of color, immigrant fellowships, worshipping communities of color, leaders of color, and members of the LGBTQIA+ communities. Such activities/programs of CORE include supporting the flourishing of these communities and their leaders through subject-matter expertise and consultation, financial resources, connecting with intra-, inter- presbytery, mid-council, denominational, churchwide, and civic resources, networks, and nurturing of relationships

Action: The Council dismissed the Working Group with thanks. Ruling Elders Sharon Rowser (San Jose-Foothill Community) and Lynn Gunter (Monterey-El Estero) and Teaching Elders Hardy Kim (Sunnyvale) and Vincent Arishvara (San Jose-Trinity)

In its oversight of budget formation, the Coordinating Council will seek to provide adequate resources for the activities/programs of CORE as it carries out its constitutional responsibilities, focused primarily on the strategic vision/direction for 2025-2027.

When the Standing Rules of the Presbytery are amended later in 2026, the strategic vision for CORE should be included.

Committee on Preparation for Ministry- Jim Bennett

The CPM continues with the same six inquirers/candidates. They will be meeting next week and expect that soon one of the candidates will be ready to be certified ready for a call.

Committee on Ministry- Lizanne Reynolds

COM is bringing edits to four COM policies to the Presbytery meeting. These are not substantive or complex, unlike last year's edits to the minimum terms of call policy thus they will not require two readings.

Polity and Government Subcommittee- Bryan Franzen

Polity and Government met on September 17 and reviewed the GA overture from Westhope and have determined that it is in good and decent order and stand ready to move it for consideration at the Presbytery Meeting

Polity and Government examined the Coordinating Council's directive to review the by-laws as it pertains to nominations. There is a high likelihood we will be permanently changing our Standing meeting schedule. The recommendation from Polity and Government is that it would be better to do a full review and reworking of the Standing Rules next year with the input of whoever might be called as the new Stated clerk.

In addition, Polity and Government identified the motions required to suspend particular provisions and requirements in the Standing Rules until the final amendments to the Standing Rules are approved.

Action: Coord. Council approved the plan for the Polity and Government committee, with input from the Presbytery Executive and/or the Stated Clerk, to review the standing rules making adjustments and updates to reflect the current practices, policies and needs of the Presbytery. The results of this shall be voted on at the last called presbytery meeting of 2026.

Action: Coord. Council approved calling an informational zoom meeting set by the at least 1 month prior to the last called meeting of 2026 to review and discuss all changes to the standing rules that will be proposed.

Action: Coord. Council recommends the following motions to Presbytery

- 1) Presbytery to approve suspending the Standing Rules as it pertains to nominating directives for minimum attendance requirements until a full review of the standing rules is completed and ratified.
- 2) Presbytery to approve suspending the Standing Rules as it pertains to the times and planning of the Stated meetings for the Presbytery until a full review of the standing rules is completed and ratified.
- 3) Presbytery to grant the responsibility of setting the time and date and planning of the Called Meetings to a committee designated by the Presbytery Coordinating Council until a full review and edit of the Standing Rules is completed and ratified.

Note: These three Motions need 2/3rds approval. *standing Rules 9.20 says “These rules may be suspended by a two-thirds vote of those present except when the Form of Government makes other requirements.”*

2026 Staffing Plan

Action: The Coordinating Council approve and affirms the 2026 Presbytery Staffing model presented by the Personnel Committee (see attached)

Action: The Coordinating Council recommends that Presbytery approve the 2026 Budget presented by Financial Affairs.

3. Dismiss the Working Group with thanks.

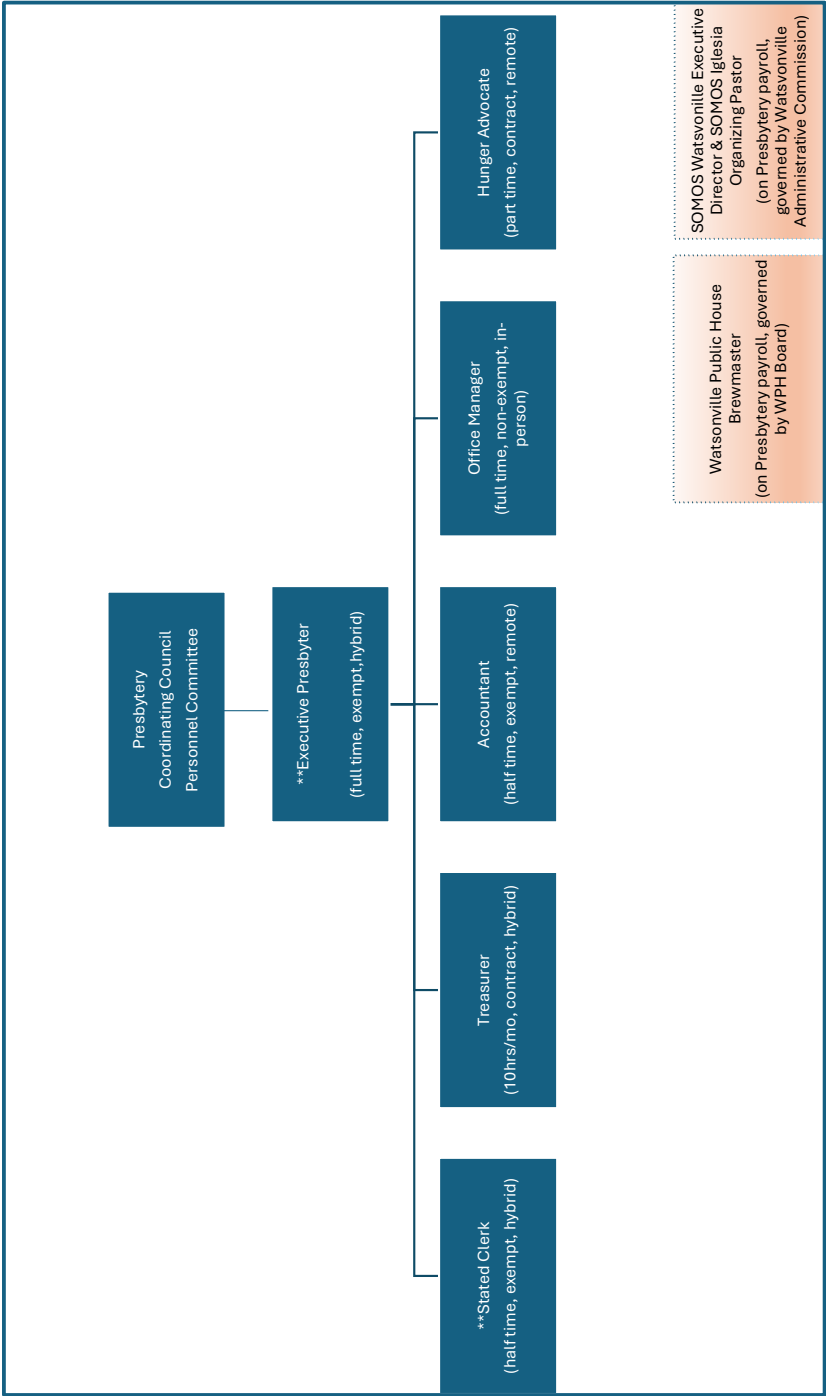
Background:

On January 30, 2025, the Coordinating Council deputized the Executive Presbyter and Stated Clerk to appoint and convene a small work group to analyze the purpose/charter of the Committee on Representation and Empowerment (CORE) so as to recalibrate and reinvigorate CORE's role, presence, and ministry in the life of the Presbytery. The following served as the Working Group: Ruling Elders Sharon Rowser (San Jose-Foothill Community) and Lynn Gunter (Monterey-El Estero) and Teaching Elders Hardy Kim (Sunnyvale) and Vincent Arishvara (San Jose-Trinity); Executive Presbyter Neal Presa and Stated Clerk Erica Rader served as staff resource.

The Working Group met three times via Zoom -- April 4, April 28, and June 3 -- and corresponded via email. The Working Group reviewed and analyzed the Book of Order mandate of committees on representation in G-3.0103 and the Presbytery's Standing Rules in section 4.70. The Working Group learned about the practices and policies of other mid councils for their respective committees on representation (and the diverse nomenclatures mid councils utilize). Such mid councils included the Presbytery of Long Island, the Presbytery of Northern New England, the Presbytery of San Francisco, the Presbytery of Wabash Valley, the Presbytery of Highlands, the Presbytery of Cascades, the Presbytery of Scioto Valley, and the Presbytery of Charleston-Atlantic.

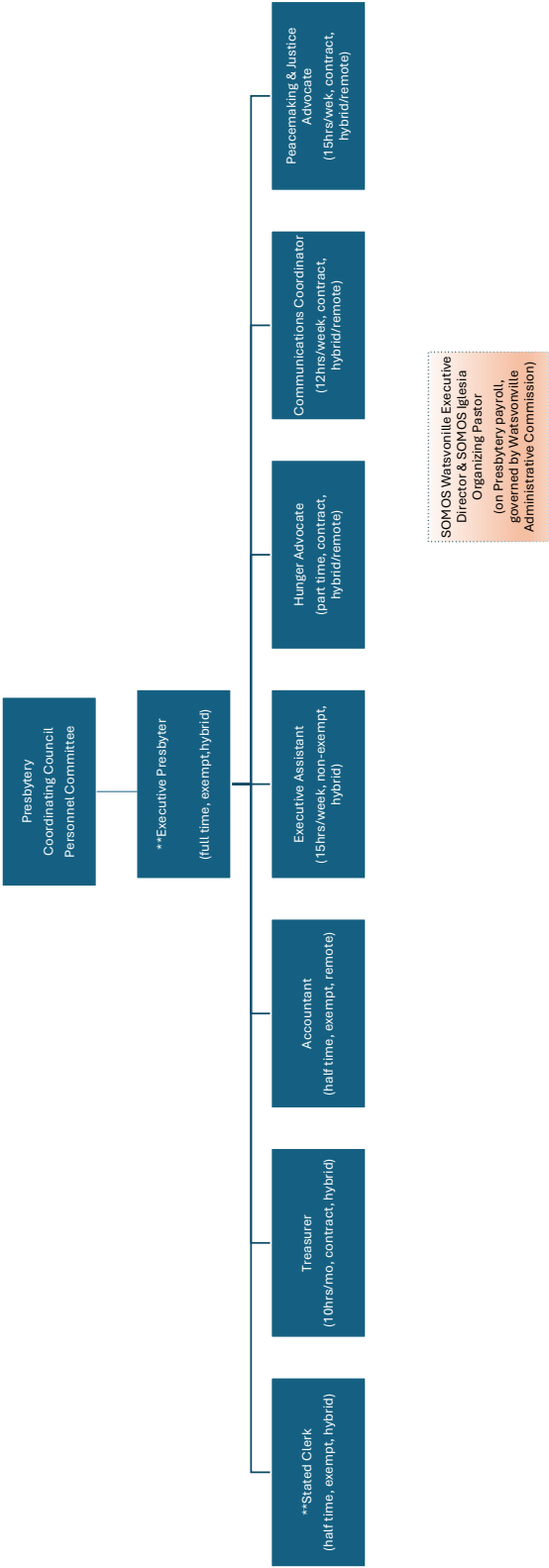
The Working Group established a survey to receive input from presbyters in our Presbytery on their awareness of past activities of CORE, particularly programs in the aftermath of George Floyd's murder in the summer 2020. As well, the survey sought to understand presbyters' thoughts of where they thought the appropriate setting of formational work ought to occur (congregational or local ministry level, presbytery gatherings), what activities are needed from CORE (advocacy, convening groups, convening conversations, providing resources, connecting resources), and presbyters' level of interest in the work of CORE. The Working Group had extensive discussion on hopes for the Church and the Presbytery, and how best to live into God's call to be diverse, to dignify the beauty of diversity, and how to support and empower one another in doing so.

New staffing design beginning in 2026 recognizes the reality of the diminished footprint of Presbytery staff at the 890 Meridian Way campus, turns over operational control of the campus to Cornerstone Church of Silicon Valley (our fastest-growing and youngest, by demographic, congregation), and creates three new positions that are focused on three particular ministry areas: administrative support to the Executive Presbyter, communications, and peacemaking/justice. The new staff design leverages resources for nimble ministry, accompanying and supporting our congregations/worshipping communities/affiliated non-profit entities. As well, the new staff design provides an overall financial savings to the budget and reduces the draw from the Presbytery's investment holdings.

The Task Force should celebrate with the Presbytery the successful ministries of the affiliated non-profit entity it is reviewing. The Task Force will report to the Coordinating Council and make recommendations as appropriate.

Presbytery of San Jose Committee on Ministry
Report to Presbytery October 23, 2025
(covering March 2025 – October 2025 activities)

Items for Docket:

Adopt amendments to Presbytery Policies PS-1, PS-3, PS-4, and PS-6; and repeal Presbytery Policy PS-2 (the substance of which has been incorporated in amended Policy PS-1).

Information Items:

7. Necrology: The only minister member death for the year was Honorably Retired Reverend Judith Joy (October 19, 1944 – September 3, 2025), in Chatham, Massachusetts.
8. Following the Presbytery's adoption of the new Commissioned Ruling Elder (CRE) policy in February 2025, the COM Subcommittee on CREs was formed and began implementing the CRE program. Six ruling elders quickly enrolled in the program. In June 2025, COM examined Tim Parmentier from Trinity San Jose and determined that he has fulfilled all CRE requirements and is eligible for commissioning as a CRE by his church.
9. During an eight-month process, COM reviewed Presbytery Policies PS-1 through PS-6, and voted to recommend several changes all but policy PS-5. Clean and redlined versions are attached to this report. COM is requesting that Presbytery approve these revisions without a second reading. While a second reading has become routine, it is not required.
10. Several Teaching Elders have not completed the required Boundary Training, which is very important and cannot be waived. Pursuant to Presbytery Policy EC-2, COM has approved the use of an online "SafeGathering" training (<https://safegatherings.com/app/get-started-clergy-course>) for pastors who could not attend the Presbytery's 2024 training sessions. COM will work with Presbytery staff to circulate this information to pastors.
11. COM approved the following minister membership transfers:
 - a. Hon. Ret. Rev. Craig Roberts to Cascades Presbytery.
 - b. Rev. Karin Hejmanowski to Cascades Presbytery.
12. COM also approved the following:
 - a. Sabbaticals for Revs. Erica Rader and Andy and Lindsay Wong.
 - b. A continuing contract between Rev. Fred Harrell and Stone Church for Transitional Pastor services.
 - c. The receipt and transfer of membership of Rev. Dr. "Paul" Prasartpong Pansuay from the Church of Christ in Thailand to PC(USA) contingent upon the chartering of First Thai Presbyterian Church in San Jose.
 - d. A Mission Study Report for Stone Church.
 - e. Permission for Rev. Andrew Yoo to labor out of bounds and validation of his ministry in Liberia through the Global Mission Society.
 - f. A status change for Rev. Jason Barraca from Stated Supply to Designated Pastor for a three-year term at Lincoln Avenue Presbyterian Church and terms of call.
13. The Minimum Terms of Call will be automatically updated effective January 1, 2026 to reflect the new social security COLA. The COLA is expected to be announced October 24th, and is estimated to be 2.7%. Clerks of Session and Session moderators will be notified of the new minimums soon thereafter.

PASTORAL TERMS OF CALL**Policy PS-1****PASTOR TERMS OF CALL****Policy Statement**

The Presbytery of San José requires that terms of call for all pastors (including transitional pastors) include the following categories: salary and housing, auto allowance, study leave, Board of Pensions dues, and vacation. It is the responsibility of each church to make it possible for all ordained staff to find and afford decent and appropriate housing reasonably close to the church. Additionally, the Presbytery requires that each church comply with federal, state and local government tax, vacation and salary requirements.

Each pastor's terms of call shall be reviewed annually by the session and approved by the congregation. After congregation approval, the terms of call shall be forwarded to the Committee on Ministry for review of compliance with this policy. All terms of call shall comply with the minimum requirements referenced in this policy for the entire calendar year at issue regardless of the church's fiscal year, budget cycle, or congregational meeting schedule.

Rationale

The Presbytery of San José provides this information in order to guide congregations in fulfilling their commitment to pay fairly the ministers who serve them and to enhance communication between the church and its pastor(s) concerning the issue of compensation and benefits

Responsibilities**Committee on Ministry (COM) Responsibilities**

At the request of any session, personnel committee or pastor, COM shall provide a representative to be present for terms of call negotiation.

COM shall review and approve terms of call for newly-installed pastors.

COM shall ensure that all terms are in writing and are clearly understood by the pastor and the session.

COM shall annually review terms of call for continuing pastors and follow up with churches that do not meet the minimum terms of call.

COM shall consider a particular church's request for exemption from this policy.

COM shall report to Presbytery the annual cost of living (COLA) figures as reported by the Social Security Administration, with the annual salary component adjustments reflecting these figures (See Appendix A for Methodology) The minimum terms of call in this policy shall be automatically adjusted to reflect the COLA effective January 1st of the following calendar year without any formal action by COM or the Presbytery.

COM shall distribute annually to all pastors the appropriate form for reporting terms of call.

Minister Responsibilities

Ministers shall familiarize themselves with this policy.

Ministers shall report the approved terms of call annually to the Executive Presbyter or the Stated Clerk by January 31 of each year.

Should a minister desire an outside consultant to assist in compensation discussions, they shall request assistance from COM.

Session Responsibilities

The session shall recommend annually to the congregation a salary that recognizes with fairness the unique gifts the pastor(s) brings to the church, and shall recommend Terms of Call that meet or exceed the minimum terms of call set forth in Appendix A. The congregation shall vote whether to approve the Terms of Call.

The session may allocate as reimbursable such professional expenses that include, but are not limited to:

- a. travel and living expenses for activities associated with performance of duties (e.g., attendance at General Assembly);
- b. hospitality expenses;
- c. book allowance;
- d. professional organizations and publications;
- e. continuing education expense for ministry-related courses other than those taken during study leave.

The session shall explain the components of the terms of call to the congregation.

The session may request COM assistance for pastoral compensation guidance and for an exemption from this policy, stating reasons for the request.

Stated Clerk and Executive Presbyter Responsibilities

The Executive Presbyter and/or the Stated Clerk shall maintain records of terms of call for each minister.

Additional Responsibilities/Information

Congregations and ministers may agree to allocate the Salary and Housing components of the minimum Terms of Call in a manner that meets both of their needs as they see fit, consistent with requirements of local, county, state, and federal taxing authorities.

APPENDIX A

Components for the Minimum Terms of Call

The minimum Terms of Call consist of the following components:

- **Minimum Salary and Housing:** For a given year, the amount in Appendix B from the preceding year, will be automatically indexed by the Social Security Administration Cost of Living Adjustment (COLA). See <https://www.ssa.gov/cola/>. The actual housing provided shall take into account the particular minister's reasonable needs and shall, at a minimum, provide a two-bedroom residence within a reasonable driving distance of the church or an equivalent cash allowance.
- **Effective Salary:** Typically comprised of Salary and Housing. The Board of Pensions may call for inclusion of other compensation in Effective Salary. Refer to The Board of Pensions publication "Understanding Effective Salary." See <https://www.pensions.org/file/what-we-offer/benefits-guidance/forms-documents/Documents/pln-103.pdf/>.
- **Board of Pensions:** The yearly designated dues (medical, pension, and death and disability) for the pastor shall comply with the current Board of Pensions requirements. (www.pensions.org)
- **Spouse and Family Medical Coverage:** The pastor's spouse and immediate family shall have health insurance coverage through either the spouse's separate employment, the Board of Pensions, Covered California, Medicare, or another public or private insurance program.
- **Auto Allowance**
- **Study Leave:** Minimum requirements are 14 calendar days per calendar year and \$1,000 (reimbursed expenses); refer to PS-6, *Use of Study Leave*, for additional requirements.
- **Vacation** –30 calendar days. The 30 days includes weekends but not federal government holidays. A pastor accrues vacation at a rate of 2.5 days per month as of the first day of each month unless a church session approves a different vacation accrual schedule. With session approval, a pastor may take vacation days before having sufficient accrued days. Session shall have a mechanism to track accrued and taken vacation days and report them to the pastor.
The maximum amount of accrued vacation is 45 days unless a church session approves a different maximum amount (but not less than 30 days). At dissolution of a pastoral relationship, reimbursement for unused but accrued vacation is calculated by multiplying the effective salary by the number of unused accrued vacation days and dividing by 365.

APPENDIX B

Minimum effective salary for full-time pastors, by county in which the church is located, shall be as follows for calendar year 2025:

Santa Clara County:	\$117,857
Santa Cruz County:	\$98,770
Monterey County:	\$72,324

See Policy PS-2 for policies applicable to Part-Time Pastors.

Policy Statement

The Presbytery of San José requires that terms of call for all pastors (including transitional pastors) include the following categories: salary and housing, auto allowance, study leave, Board of Pensions dues, and vacation. It is the responsibility of each church to make it possible for all ordained staff to find and afford decent and appropriate housing reasonably close to the church. Additionally, the Presbytery requires that each church comply with federal, state and local government tax, vacation and salary requirements.

Each pastor's terms of call shall be reviewed annually by the session and approved by the congregation. After congregation approval, the terms of call shall be forwarded to the Committee on Ministry for review of compliance with this policy. All terms of call shall comply with the minimum requirements referenced in this policy for the entire calendar year at issue regardless of the church's fiscal year, budget cycle, or congregational meeting schedule.

Rationale

The Presbytery of San José provides this information in order to guide congregations in fulfilling their commitment to pay fairly the ministers who serve them and to enhance communication between the church and its pastor(s) concerning the issue of compensation and benefits

Responsibilities

Committee on Ministry (COM) Responsibilities

At the request of any session, personnel committee or pastor, COM shall provide a representative to be present for terms of call negotiation.

COM shall review and approve terms of call for newly-installed pastors.

COM shall ensure that all terms are in writing and are clearly understood by the pastor and the session.

COM shall annually review terms of call for continuing pastors and follow up with churches that do not meet the minimum terms of call.

COM shall consider a particular church's request for exemption from this policy.

COM shall report to Presbytery the annual cost of living (COLA) figures as reported by the Social Security Administration, with the annual salary component adjustments reflecting these figures (See Appendix A for Methodology) The minimum terms of call in this policy shall be automatically adjusted to reflect the COLA effective January 1st of the following calendar year without any formal action by COM or the Presbytery.

COM shall distribute annually to all pastors the appropriate form for reporting terms of call.

Minister Responsibilities

Ministers shall familiarize themselves with this policy.

Ministers shall report the approved terms of call annually to the Executive Presbyter or the Stated Clerk by January 31st of each year.

Should a minister desire an outside consultant to assist in compensation discussions, they shall request assistance from COM.

Session Responsibilities

The session shall recommend annually to the congregation a salary that recognizes with fairness the unique gifts the pastor(s) brings to the church, and shall recommend Terms of Call that meet or exceed the minimum terms of call set forth in Appendix A. The congregation shall vote whether to approve the Terms of Call.

The session may allocate as reimbursable such professional expenses that include, but are not limited to:

- a. travel and living expenses for activities associated with performance of duties (e.g., attendance at General Assembly);
- b. hospitality expenses;
- c. book allowance;
- d. professional organizations and publications;
- e. continuing education expense for ministry-related courses other than those taken during study leave.

The session shall explain the components of the terms of call to the congregation.

The session may request COM assistance for pastoral compensation guidance and for an exemption from this policy, stating reasons for the request.

Stated Clerk and Executive Presbyter Responsibilities

The Executive Presbyter and/or the Stated Clerk shall maintain records of terms of call for each minister.

Additional Responsibilities/Information

Congregations and ministers may agree to allocate the Salary and Housing components of the minimum Terms of Call in a manner that meets both of their needs as they see fit, consistent with requirements of local, county, state, and federal taxing authorities.

APPENDIX A

Components for the Minimum Terms of Call

The minimum Terms of Call consist of the following components:

- **Minimum Salary and Housing:** For a given year, the amount in Appendix B from the preceding year, will be automatically indexed by the Social Security Administration Cost of Living Adjustment (COLA). See <https://www.ssa.gov/cola/>. The actual housing provided shall take into account the particular minister's reasonable needs and shall, at a minimum, provide a two-bedroom residence within a reasonable driving distance of the church or an equivalent cash allowance.
- **Effective Salary:** Typically comprised of Salary and Housing. The Board of Pensions may call for inclusion of other compensation in Effective Salary. Refer to The Board of Pensions publication "Understanding Effective Salary." See <https://www.pensions.org/file/what-we-offer/benefits-guidance/forms-documents/Documents/pln-103.pdf/>.
- **Board of Pensions:** The yearly designated dues (medical, pension, and death and disability) for the pastor shall comply with the current Board of Pensions requirements. (www.pensions.org)
- **Spouse and Family Medical Coverage:** The pastor's spouse and immediate family shall have health insurance coverage through either the spouse's separate employment, the Board of Pensions, Covered California, Medicare, or another public or private insurance program.
- **Auto Allowance**
- **Study Leave:** Minimum requirements are 14 calendar days per calendar year and \$1,000 (reimbursed expenses); refer to PS-6, *Use of Study Leave*, for additional requirements.
- **Vacation** –30 calendar days. The 30 days includes weekends but not federal government holidays. A pastor accrues vacation at a rate of 2.5 days per month as of the first day of each month unless a church session approves a different vacation accrual schedule. With session approval, a pastor may take vacation days before having sufficient accrued days. Session shall have a mechanism to track accrued and taken vacation days and report them to the pastor.
The maximum amount of accrued vacation is 45 days unless a church session approves a different maximum amount (but not less than 30 days). At dissolution of a pastoral relationship, reimbursement for unused but accrued vacation is calculated by multiplying the effective salary by the number of unused accrued vacation days and dividing by 365.

JOB DESCRIPTION/PERFORMANCE REVIEW FOR PASTORS Policy PS-3

I. Policy Statement

The session personnel committee shall provide each pastor or associate pastor with a current (or updated) job description and reasonable performance standards/objectives to be mutually confirmed and reviewed with him/her annually.

II. Rationale

Pastors need the expectations of their sessions to be clearly defined and mutually agreed upon as to the nature and priority of their work of ministry. Session needs the expectations and priorities of their pastors to be clearly defined and evaluated annually.

III. Responsibilities

A. Committee on Ministry (COM) Responsibilities

COM shall: assure that each church has an active personnel committee provided with all necessary guidance; review and approve all job descriptions for pastors and associate pastors as submitted by their sessions or Pastor Nominating Committees.

B. Minister Responsibilities

Ministers should encourage sessions to form a personnel committee if one is not in existence; and should inform COM of any difficulties encountered in working with their personnel committees.

C. Session Responsibilities

Session shall establish and give oversight to an active personnel committee; advise COM of any alternate plan for this responsibility; and make available pastor job description(s) at this triennial visit.

D. Additional Responsibilities/Information

Personnel committees shall provide at a minimum an annual review of the job description for all pastors; meet annually with each pastor to review job description, expectations and performance; and establish an annual priority of tasks and agree on an equitable plan for measuring accomplishment.

A booklet, “Guidelines for a Session Personnel Committee” is a resource for specific information and sample “position descriptions” and “performance reviews”, available from Presbytery and denominational offices.

PART-TIME PASTORS

Policy PS-4

I. Policy Statement

Employment conditions and benefits for part-time pastors or associate pastors shall be consistent with those granted to their full-time counterparts. The only adjustments shall be based on the total working hours required for the part-time position.

The Presbytery of San Jose allows vacation and study leave to be prorated according to the percentage of the part-time call. See Policy PS-1 —Pastor Terms of Call.

II. Rationale

A congregation may choose to employ a part-time pastor or associate pastor and a pastor may desire to work part-time. In order to avoid frustration and disappointment for all parties, congregational and pastoral expectations need to be clearly defined, and congregations and pastors need to fully understand and agree upon the limitations of a part-time pastoral position. A combination of what the church needs, can afford, and the importance it places on the job, and the pastor's needs are relevant factors in determining the pastor's hours.

III. Responsibilities

A. Committee on Ministry (COM) Responsibilities

1. Helps PNC, APNC or session define job and negotiate hours.
2. Provides information on compensation (See Policy PS-1 — Pastor Terms of Call).
3. Approves terms of call.

B. Part-Time Pastor Responsibilities

1. Understands congregation's expectation for position.
2. Works with church's personnel committee and session to develop a realistic written job description with measurable goals and limitations.
3. Communicates to congregation as often as needed the time constraints imposed by part-time status.

C. Session Responsibilities

1. Works with PNC or APNC to determine terms of call, in compliance with this policy and Policy PS-1, and calls a congregational meeting for a vote on the candidate put forward by the PNC or APNC.
2. Clearly delineates lines of responsibility between pastor(s) and members of staff.

3. Works with part-time pastor to create realistic job description with measurable goals.
4. Empowers church personnel committee to monitor adherence to job description/ hours.
5. Provides for an annual job performance review and evaluation of mutually determined goals.

USE OF STUDY LEAVE

Policy PS-6

I. Policy Statement

The purpose of study leave is to provide for the ministers' professional and spiritual growth which benefits both the minister and the church. Failure to utilize study leave diminishes a minister's effectiveness and deprives the church of maturing leadership.

III. Responsibilities

A. Committee on Ministry (COM) Responsibilities

COM shall determine the minimum amount of study leave that a church shall provide its ministers pursuant to Policy PS-1.

B. Minister Responsibilities

Ministers shall submit annually study leave plans to their session for approval. Ministers shall report use of study leave time when requested by the COM.

Ministers planning on accruing time and funds for advanced degree study or an extended study plan shall coordinate with their session well in advance to ensure that provisions are made for uninterrupted pastoral care and leadership.

C. Session Responsibilities

The session shall encourage its minister(s) to utilize study leave on an annual basis. Study leave funds and time should be used annually but may be accrued up to three years by agreement between the pastor and session when used to pursue an extended project. When a pastor leaves a call with accrued study leave funds, all such funds are forfeited.

Title: On Taking Action to Repudiate Christian Nationalism and Affirm Our Faith Commitments

The Presbytery of San Jose respectfully overtures the 227th General Assembly (2026) to:

1. Direct the Stated Clerk to send the following proposed amendment to the Book of Order to the presbyteries for their affirmative or negative votes:

Shall F-1.0404 be amended to add the following statement after . . . *“a new openness to God’s continuing reformation of the Church ecumenical, that it might be more effective in its mission.”*: *“The church shall not align with any ideology that seeks to privilege Christianity in public life or conflate religious identity with national or ethnic supremacy. Christian Nationalism, in all its forms, which seeks to privilege a singular religious-cultural framework in civic life, is: incompatible with the example and teachings of Jesus Christ, a theological error, a threat to faithful witness, and contrary to the church.”*;

2. Direct the Stated Clerk and the Moderator to issue a joint statement calling attention to the dangers and distortions of Christian Nationalism as an urgent theological and social concern of our time, providing moral clarity and guidance for the Church and the larger society.
3. Engage with other faith traditions to form a coalition to: speak out against Christian Nationalism, engage in a collective actions, and deconstruct practices, theologies, and patterns of Christian Nationalism in the Church and society at large.

Rationale

Christian Nationalism is a dangerous and increasingly pervasive ideology that seeks to merge national identity with Christian identity, distorting both faith and politics. The requested actions in this overture aim to affirm the church's unwavering commitment to a gospel that stands in opposition to exclusionary political power and theologies that distort the example and teachings of Christ.

Christian Nationalism contradicts the foundational commitments and public witness of our church: love, equality, inclusion, peace, religious freedom and the *imago dei* of all beings. It substitutes the call of Christ to love our neighbor with a coercive and divisive ideology of fear and violence. As followers of Jesus Christ and members of the Reformed tradition, we cannot remain silent in the face of this threat.

The Growing Threat of Christian Nationalism

Christian Nationalism has been steadily gaining ground in the United States, with political figures invoking religious language to justify harmful policies that marginalize immigrants, people of color, LGBTQIA+ individuals, religious minorities, women, children, and other vulnerable populations.

Public opinion research, including a Pew Research report from February 2025, found that 54% of Mainline Protestants support the idea of declaring the U.S. a "Christian nation." While the term "Christian nation" has been popularized in media and political discourse, this belief often signals a desire for the state to reflect and privilege a particular religious identity, rather than simply a moral framework. This conflation of national identity with Christian identity runs counter to the principles of religious freedom and pluralism to which the PCUSA is already committed, and that form the foundation of democratic societies.

In addition, 57% of Mainline Protestants favor allowing prayer in public schools, specifically in Jesus' name, 63% support prayer to "God" in public settings, and 60% favor allowing cities and towns to display religious symbols on public property. These trends reflect a desire to embed Christianity into the civic sphere, reinforcing the dangerous assumption that the state has the authority to promote a singular religious framework, at the expense of other faith traditions and non-believers.

This rising trend must be met with a strong and public response from the church. Christian Nationalism not only distorts the gospel, but does so in its aim to reshape society in a way that contradict the gospel values of justice, inclusion, and equality.

Theological and Confessional Rejection of Christian Nationalism

The Presbyterian Church (U.S.A.) has long affirmed its commitment to justice, religious freedom, and the separation of church and state. This commitment is rooted in our confessional documents, which reject any theology that seeks to elevate national or political power above the sovereignty of God.

- The Barmen Declaration (1934) affirms that the church must not align itself with any political ideology, rejecting the attempt to merge Christian faith with state power.
- The Confession of 1967 calls for the church to stand against systemic injustice and racism.
- The Belhar Confession (1986) explicitly rejects any form of theology that promotes national or racial superiority.
- A Brief Statement of Faith (1991) affirms that "we trust in the one triune God, whom alone we worship and serve."

These confessions remind us that the church's loyalty is to God alone, and any attempt to merge Christian faith with political power is a form of idolatry that distorts the gospel. Christian Nationalism directly contradicts these theological commitments and the example set by Jesus Christ, who called his followers to love their neighbors without regard to nationality, race, gender, status, or creed.

The Church's Call to Act

The PC(USA) has repeatedly affirmed the importance of religious freedom and the separation of church and state. In addition, the Church has a long history of public witness and commitment to racial justice, LGBTQIA+ inclusion, immigrant protection, and interfaith solidarity. Christian nationalism violates each of these principles; it is a distortion of the gospel that undermines the church's prophetic voice in the world. In the face of these threats, silence is not an option.

Christian Nationalism presents a clear and present danger to both the integrity of Christian faith and the health of democracy. It distorts the gospel and seeks to impose a singular religious identity on a pluralistic society. The PCUSA is called to witness to the truth of the gospel, which is one of radical inclusion, justice, and love for all people. The actions requested in this overture—to amend the Book of Order, issue a public statement, and seek to be a contributing member of a broad-based coalition—are necessary steps in dismantling the theological distortions and political ideologies that have sought to merge Christianity with state power.

Now, more than ever, the church must stand firm in its commitment to the gospel and to the values of democracy and justice. We must reject Christian Nationalism in all its forms and act decisively to protect both our faith and our democracy.

Westhope Presbyterian Church moves that the Presbytery of San Jose concur with this overture:

Presbytery of San Francisco - Resolution on the Israel/Palestinian Hostility: Our Kairos Moment

RESOLVED that, as the Presbytery of San Francisco, we:

- 1. Listen** to Dr. King's prophetic witness that "there comes a time when silence is betrayal," realizing that we cannot remain silent to the wanton killing that has taken place in Gaza and the Middle East.
- 2. Condemn** unequivocally the attack by Hamas on Israel on Oct 7, 2023.
- 3. Condemn** unequivocally the genocide perpetrated by Israel with US support against the Palestinian people.
- 4. Recognize** the long term project by Israel to remove Palestinians from the Holy Land parallels our US "settler-colonialist" history, where American settlers similarly gained from dehumanizing our indigenous population.
- 5. Call** on the President and US congress to block military sales to Israel in accordance with US laws and the [POSITION OF THE GENERAL ASSEMBLY OF THE PCUSA](#).
- 6. Encourage** congregation members and ministers of Word and Sacrament to ask congress to urgently halt weapons sales to Israel.
- 7. Express** our commitment to justice and lasting peace for the Israeli and Palestinian peoples.
- 8. Stand** against all forms of Antisemitism/Anti-Jewish racism and Islamophobia/Anti-Arab racism, condemning both as pernicious forms of evil, dividing and separating us from our interfaith siblings, and stand with those threatened with any harm that inhibits their full participation in the life and liberty of our communities. We affirm that standing up for our values is not Antisemitism.
- 9. Encourage** our member congregations to preach and teach on these critical issues.
- 10. Publicize**, as Presbytery, this resolution's passage on our webpage, and as practical, in other print or digital formats, and encourage congregations to adopt this resolution, or write and affirm one themselves.

RATIONAL:

1. This is a Kairos moment, a moment of danger and opportunity, a time when we can move forward, boldly proclaiming the Gospel of Christ, the Prince of Peace, or be silent while thousands have suffered and died.

We believe each life is precious. Each life taken, each parent, child, grandchild killed since October 7, 2023, was someone else's entire world. We mourn the Palestinians killed by the Israeli military, officially, more than 50,000 as of this writing, mourn the 1,200 Israelis killed in the attack of October 7.

Considering the staggering loss of life, the ongoing targeting of civilian populations, the harm and trauma inflicted upon women and children, the resurgence of polio and the use of starvation and thirst as weapons of war, we raise our voice against such brutality, the indiscriminate killing of all innocents.

Our government provides offensive weapons used against civilians. Our tax dollars are used to kill and maim women and children, enabling genocide, making us complicit in this atrocity. If "there comes a time when silence is betrayal," then who or what is being betrayed? We betray all who struggle to survive. We also betray our values. Jesus teaches us, "Whatsoever you do to the least of these, you do to me." (Matt 25:40) Can we justify silence in the face of suffering, death and destruction?

2. The crimes against humanity committed by Israel following October 7; making that the start of the "war", is misleading. October 7th was not the beginning of this conflict, and the attack emerged from a much longer context. The fact that decades of the "peace process" yielded nothing, in no small part due to US policy, helps explain why the attacks took place. Violence might have been prevented had the US and Israel engaged in good-faith, peaceful negotiations. The majority of Palestinians in Gaza are displaced people, mainly from the war of 1948. The atrocity of October 7th, 2023, which resulted in approximately 1200 deaths and over 250 people taken hostage, likely constituting war crimes and should be prosecuted as such. Under international law, Israel has a right to defend itself, but not the right to respond disproportionately or to target civilians.

3. The retaliation by Israel on Gaza has been extraordinarily and disproportionately brutal. Some estimates indicate at least 220,000 Palestinians, including at least 17,000 children have been massacred, 21,000 missing, some 4,000 trapped under the rubble, many vaporized by the latest American-made carpet bomb technology. 1.8 million Palestinians are facing imminent death by starvation. Israel has destroyed 14 times more structures than all conflicts over the past 16 years combined. Every university in Gaza has been obliterated. The devastation to homes, churches, mosques, agriculture, hospitals and infrastructure is incalculable and growing. 1.9 million Gazans have been displaced multiple times. 1,400 Palestinian doctors and nurses, 341 aid workers, and 191 journalists have been killed in the past year; some assassinated, burned alive, bulldozed alive, buried alive, or raped to death in Israeli torture camps.⁽¹⁾ Ambulances are targeted. Israel blocks food and humanitarian supplies. Children are dying of starvation. Corpses which Israel prevents from being retrieved, litter the streets and are consumed by dogs. 95% of Gazan schools have been destroyed. More than 4,000 people have had their upper or lower limbs amputated. Children undergo surgeries and amputations without anesthesia. More than 2,000 people with spinal and brain injuries are bedridden and in urgent need of rehabilitation. At least 50,000 Palestinian children have been orphaned.

Witnesses tell of tear-streaked, panicky children covered in dust, who run in the streets as warplanes and drones roar overhead. Some plead for water, but Israeli soldiers refuse to give them anything, and instead pour water on the ground in front of them. At the checkpoint, Israeli troops separate the men and detain them as their families scream in anguish. Children cling to Israeli tanks desperately attempting to stay with their fathers. As families are forced to walk 10 kilometers south to Gaza City, some of the wounded fall on the road with no hope of getting treatment. "I was walking with my sister in the street," said Rahaf, 16. She and her sister were the sole survivors in their family of an earlier airstrike that killed 70 people. "Suddenly my sister fell due to the bombing. I saw blood pouring from her, but I couldn't do anything. I left her in the street, and no one pulled her out. I was screaming, but no one heard me."

The consensus among international scholars is that Israel has committed genocide or that genocide is imminent. ⁽²⁾ Amnesty International has called this genocide and an ongoing genocide. Human Rights Watch says that Israel's policy of denying clean water legally amounts to acts of genocide and extermination. This means Israeli authorities have committed the ongoing crime against humanity of extermination under the Genocide Convention of 1948. The government of South Africa instituted proceedings against Israel at the International Court of Justice (ICJ) alleging a violation of the Genocide Convention. The ICJ ruled that the allegations have merit, and the threat of genocide is "plausible" and ordered Israel to observe its obligations under the Genocide Convention and to allow basic humanitarian aid into Gaza. Moshe Yaalon, Benjamin Netanyahu's former Israeli defense minister, says "the current far-right government is determined to occupy, annex, ethnically cleanse: war crimes are being committed here." Israel dropped over 85,000 tons of bombs on Gaza in a year, the equivalent to nearly 6 Hiroshima atomic bombs.

In the year following October 7, the Biden administration sent nearly \$23 billion to Israel with no red lines; it vetoed four UN Security Council resolutions demanding a ceasefire; Secretary of State Antony Blinken ignored the U.S. government's own determination that Israel was blocking humanitarian aid to Gaza when he delivered a statement under oath to Congress last May; the United States has violated its own laws—including the Arms Export Control Act, Section 620i of the Foreign Assistance Act, and National Security Memorandum-20—conditioning U.S. military aid to state belligerents on their compliance with U.S. and international laws of war; the United States has undermined the authority of both the International Court of Justice (ICJ) and the International Criminal Court (ICC); and 107 members of Congress sent a letter to the United Nations two weeks before the election threatening to withdraw U.S. funding and support for the organization if it allowed its members to unseat Israel, as the General Assembly had done with the South African apartheid regime in 1974.

4. We, as mostly white Americans, benefitted and continue to benefit from the settler-colonial project of our forebears. Clearly, we sought to eliminate indigenous populations in order to take the land and use its resources for our benefit. As we continue to struggle with our own complicity in the settler-colonialist projects of the past, and the devastating harm to

others, we cannot be blind to the one happening in Palestine. We assess our complicity and refuse to be complicit in ongoing genocide against Palestinians.

5. Veterans for Peace lawyers explain that there are no less than six US laws forbidding the transfer of weapons to any country when it is more likely than not that the arms will be used by that country to commit genocide, crimes against humanity, and grave breaches of the Geneva Conventions.

6. Our thoughts and prayers are not enough to offer the people of Palestine. Our faith must become a verb. One way is by communicating with our representatives using the PCUSA Office of Public Witness website: Take Action: Call on the US Congress to Block Sales of Military Aid to Israel.

7. Israel's citizens and Palestinians deserve security and justice from war and violence. Israel has imposed an apartheid system of injustice on almost every facet of Palestinian life. Most everyone who has traveled to Israel and Palestine, including our Jewish siblings, acknowledge that the occupation is apartheid, systematic ethnic cleansing, and unsustainable colonization. Our own PCUSA denomination recognizes Israel as an apartheid state. Israelis will never have the security they long for until Palestinians receive justice, and the apartheid system is dismantled.

8. We affirm that criticism of Israeli government policy, for instance, the indiscriminate bombing and withholding humanitarian aid from starving people is not antisemitic. Many fear that criticizing Israel may be interpreted as antisemitism and feel safer remaining silent rather than speaking up and risking offense. Conflating antisemitism with criticism of the Israeli nation-state makes it more difficult to identify, and therefore to combat, actual incidents of anti-Jewish bigotry and racism. We reject the "it's complicated" cliché that keeps us from speaking boldly and wading into controversy. There is nothing complicated about genocide. So, we struggle with a challenge of faith, to speak up for our values and allow some to feel uncomfortable, or stay silent and be complicit in this ongoing humanitarian catastrophe.

If we fail to speak in times of crises like this, then when will we speak? Dr. King prophetically calls us to this moment, "We are confronted with the fierce urgency of now. In this unfolding conundrum of life and history there is such a thing as being too late. Procrastination is still the thief of time...."

The Holocaust teaches us that genocide can happen as the world watches. We must not let this happen. In Congressman John Lewis' words, "If not now, then when? If not us, then who?"

Pastor Munther Isaac, Christmas Evangelical Lutheran Church in Bethlehem, in his 2023 Sermon "Christ in the Rubble: A Liturgy of Lament," proclaims: "We are angry...We are broken...Let it be clear: Silence is complicity, and empty calls for peace without a ceasefire and end to occupation, and the shallow words of empathy without direct action - are all under the banner of complicity. So here is my message: Gaza today has become the moral compass of the world. Gaza was hell on earth before October 7th. If you are not appalled by what is happening; if you are not shaken to your core - there is something wrong with your humanity."

9. It is important that we lead with our values: compassion, peace, justice, care for the afflicted, love of our neighbor. If we fail to lead, we fail our young people who long for role models to live out their faith. If we fail to inspire them, they will look elsewhere. If we choose to

ignore genocidal harm, we undermine our core values. When we take risks for our faith and proclaim our values in the public square, we boldly proclaim Jesus, the gospel of love, justice, compassion and peace.

10. It is important for congregations to be bold in speaking out so that others will also be encouraged to speak. It will not benefit anyone if the Presbytery adopts this resolution without publicizing it. This is our Kairos moment; may we have the courage to speak out against genocide.

Nominee Statement- Ruling Elder Commissioner to GA
Beth Wylie, Westhope

My journey with the Presbyterian Church began in 2019 through a search for a spiritually grounded community that could support my daily Centering Prayer practice, a core part of my spiritual formation in the Center for Action and Contemplation's Living School. I found that community at Westhope Presbyterian Church, where I was welcomed into a worship life rich with contemplative practices, rooted in the deeper tradition of Christian spiritual practices I had not experienced in the church of my upbringing, the United Methodist Church.

My journey with Presbyterianism has always been marked with mystery. The first day I showed up for morning prayer at Westhope, the pastor began chanting a sung prayer I already knew. I joined my voice with his, marveling at how this preacher in Saratoga knew the song I had learned on the remote isle of Iona in Scotland from wandering preacher John Philip Newell: *"You shall be as a garden, as a deep spring whose waters never fail..."* From this day forward, I felt the sacred mystery of belonging—a welcome into the broader, evolving story of Christian community.

Since then, I've served Westhope as a Ruling Elder for five years, as chair of the Social Justice and Marketing Committees, as a member of the Nominating Committee, as webmaster, and as co-chair of the Presbytery's Peace & Justice Work Group. Through this service, I've come to deeply value the PC(USA)'s commitment to egalitarian governance, faithful public witness, and its living history of social justice.

As I seek to serve as a commissioner to the 227th General Assembly, I carry a vision of the Church as a dynamic and inclusive body—one that is always reforming in response to the cries of the oppressed, the challenges of its time, and the call of Christ's radically inclusive love.

The PC(USA) faces several pressing challenges today: declining membership, internal division, the rise of Christian nationalism, persistent racism, and the need to decolonize mission work. But these challenges are also opportunities for transformation. We are called to celebrate diversity—not just demographically, but theologically, culturally, and structurally. Our church must continue its anti-racism work, confront the legacies of white supremacy and patriarchy, and develop deeper cultural competency to form respectful, reciprocal relationships across lines of difference.

At Westhope, I have witnessed the power of a community that meets people in the suffering of the present moment—a church that engages openly with the realities of race, class, gender, and justice. This authenticity is what draws people back to faith. We have grown, even through the pandemic, by being a contemplative and justice-oriented church that invites all voices into the conversation and sees spiritual growth and social action as intertwined.

I believe the future of our denomination lies in this kind of transformation. As we release the need to preserve the church "as it always was," we create space for resurrection—new life, new growth, and renewed purpose.

6. The Synod voted to approve the merger of Boise and Kendall presbyteries **to form the Snake River Presbytery**. The necessary documents were forwarded to the General Assembly last week and the Administrative Commission on Mid-Councils will consider the merger on December 5. Please hold all in prayer for a blessed future!
7. The Synod adopted **new bylaws** to be in compliance with California law.
8. There will be a **Special Assembly** via Zoom on Thursday, December 11 at 10:00am Pacific. This meeting should be well under one hour.
