"New Year: The Day After"

Dear Members and Friends of the Presbytery of San José,

Grace and peace in the name of Jesus Christ, who is still Lord and who is still Savior, and in the fellowship of the Holy Spirit, who is still Comforter and who is still our Breath of Life.

On New Year's Eve, as we've done for the past 22 years, my buddy and I reflected on the fact that we don't really make New Year's resolutions because every single day is a recognition that we are works-in-progress, God's mercies are new every morning (Lamentations 3:22-23), God is faithful in every season, and that each day are opportunities to resolve to do a bit better than the previous day. So whether it's December 31, 2025 or January 1, 2026, the sun still rises and sets, sin and grace will be ever present in our lives and in the world, and Christ is still Lord and Savior.

As I reflect upon 2025 and as this is Day 2 of 2026, I give thanks to God for each and all of you and for our continued partnership in the Gospel. Our commitment to God's transformative work in the world hasn't changed; in fact, I pray that it has deepened and broadened.

January 6th, while infamous in our country's history because of the tragic insurrection of 2021 in our nation's Capitol, is in our liturgical calendar the sacred Day of the Epiphany. One of the liturgies I find most moving is Reaffirmation of the Baptismal Covenant. Whether there is someone being baptized on Epiphany or the Sunday adjacent to Epiphany, it is a wonderful time for a congregation/worshipping community to reaffirm what baptism means, to concretize the commitments we have to one another and to God because we are a part of the body of Christ, and to acknowledge with gratitude that we are claimed as children of God by virtue of our adoption into God's love through Christ in the Holy Spirit.

When the Presbytery of San José hosted the 218th General Assembly in 2010, a Reaffirmation of the Baptismal Covenant liturgy was used, together with a celebration of the Lord's Table. You can access that liturgy and hopefully use it in your own contexts: [click here](#)

In that 2010 liturgy, after a litany of confessing sins and brokenness, the following is prayed:

***Lord, have mercy on us.
Remember the promises you made to us in our baptism,
forgive our sinful ways and heal our brokenness.
Set us free from all that enslaves us,
and raise us to new life in Jesus Christ,
that we may be your faithful servants,
showing forth your healing love to the world,
to the glory of your holy name. Amen.***

May that prayerful commitment be our daily resolve, not only this second day following the first day of a new year, but every single day we live and move and have our being in the presence of our God.

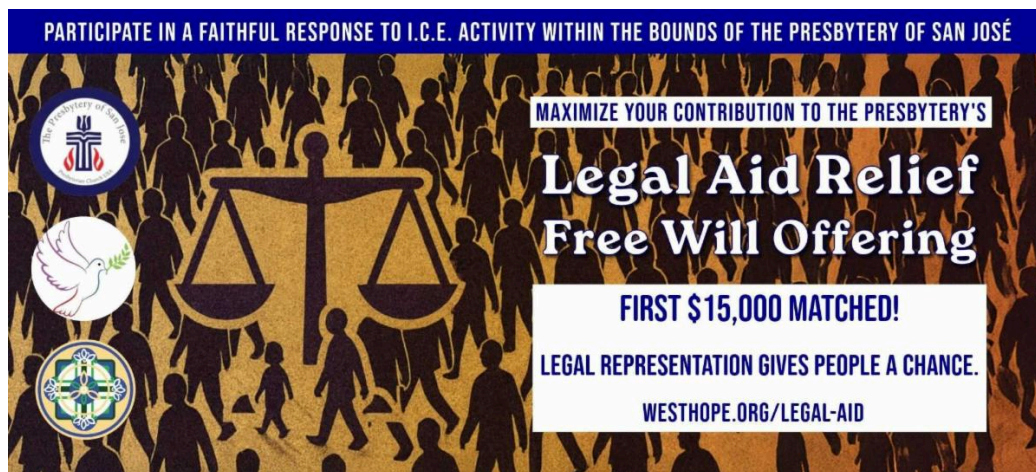

A report issued November 20, 2025 by the American Immigration Council indicated that without the benefit of an attorney at immigration court proceedings, people in our Presbytery have a 70% chance of being deported, often erroneously.

In response to this, the Presbytery's Peace and Justice Working Group has worked with EP Neal Presa to establish a free will offering initiative to support crucial legal counsel for people facing the threat of deportation. The Working Group and Presbytery staff have identified Peacemaking Offering and other related special funds that can provide up to \$15,000 in matching funds. This initiative will run through Pentecost Sunday, May 24, 2026.

Saturday, January 10th : Installation of The Rev. Jason Barraca

Jason, who has until this point served faithfully for more than a decade as the part-time Stated Supply Pastor of Lincoln Avenue, was officially approved by the Presbytery's Committee on Ministry and called by the congregation of Lincoln Avenue Presbyterian Church to serve as the full-time Designated Pastor. All are welcome to attend as we bear witness to this important milestone in LAPC's history, Jason's ministry, and our Presbytery community.



2026 Corrected Budget Approved - Coordinating Council

The Coordinating Council, acting *ad interim* Presbytery (Standing Rule 4.28.1) and at the recommendation of the Financial Affairs Committee, unanimously approved a corrected 2026 budget via online vote on December 29, 2025. This action was necessary to put in place the 2026 budget before the start of the new year, and to correct a technical error in the Excel formula that generated the budget document considered by Presbytery on October 23. All expense items listed in the budget had been previously approved by Financial Affairs Committee, Coordinating Council, and, subsequently by Presbytery. The corrected budget increases the draw from investments by \$42,900. So for 2026, the projected draw from investments will be \$550,403.26 instead of what was presented on October 23 which was \$507,503.26. This compares to the 2025 budget, which had a draw from investments of \$583,225.93.
